



THE THEME FOR THIS YEAR'S ANNUAL REPORT IS "BREAKING GROUND FOR OUR FUTURE."

It's an apropos title as you will see as you peruse this report because our College has not only been literally breaking ground for our many capital construction projects, but also "breaking ground" in initiatives and partnerships that ensure promising opportunities for our students.

We are certainly breaking ground the traditional way with the many capital construction projects our institution has initiated in the past year—exciting endeavors in which we can visually see our campus transform before our eyes. But make no mistake, these projects are not simply physically appealing structures and makeovers. Each one represents the fruition of great needs that have been long overdue. These projects will increase the value of educational opportunities for our students.

For example, the current construction of our Biotechnology Center of Excellence is a major investment in four outstanding advanced science programs, providing a regional hub for innovative, industry-supported and technology-based workforce development and jobs in the rapidly expanding field of biotechnology that supports the economic vitality of Alamance County. The Student Services Center, also under construction, will bring together many key student service departments under one roof. Space in this message precludes me from going into detail about our other exciting renovation and expansion projects, but you will see the details over the next few pages.

While this construction is very exciting, we are also "breaking ground" in other ways. For example, last January ACC, Elon University, and the Alamance Burlington School System signed an agreement we call Alamance Scholars. It's an effort to address the shortage of teachers in our local schools and to enhance the racial and ethnic diversity of educators in area classrooms. You'll also read about the very successful Career Accelerator Program (CAP) which provides a win-win opportunity for companies to create apprenticeships and for our industrial students to learn while working, and earning their academic credentials they need. We're also "breaking ground" for women in what have historically been opportunities for males with a new pathway specifically geared for young women in engineering fields.

These are the kinds of initiatives, to name only a few, in which Alamance Community College is dedicated to "breaking ground" in multiple ways. We have never been content to just sit back with our excellent roster of more than 40 curriculum programs that prepare graduates for careers.

I hope this year's annual report helps showcase all we do to serve our community. We are grateful for our community's continued support.

THE ACC **MISSION** To provide the educational programs and services of a comprehensive community college that responds to our diverse community needs and empower lifelong learners to participate in a global society.

DEAR DONORS, ALUMNI, FACULTY, STAFF, STUDENTS, **VOLUNTEERS AND FRIENDS:**

Despite, or perhaps because of the pandemic, in 2020-2021, the Alamance Community College Foundation discovered new ways of partnering with our community to enhance educational opportunities, foster innovative programs, and help students achieve.

This academic year, the ACC Foundation awarded eight faculty and staff members with a total of \$29,000 to implement innovative ideas and programs that affected over 3,000 students community-wide. Among the projects were the Smithsonian WaterWays Exhibit; a camp to introduce high school females to advanced manufacturing; the development of a garden market learning laboratory at the Covington Education Center; a childcare program at City Gate Dream Center; enhancement of the Advertising and Graphic Design Makerspace; the purchase of modernized dental radiology equipment; a professional learning community to introduce Academic and Career Readiness students to additional resources; and the Minority Male Success Initiative to increase accessibility and offer engaged outreach to male minority students.

Among the new scholarships created are the George Floyd Memorial Scholarship for Black and African American Males; NAMI Alamance, Caswell, Rockingham Scholarship for students affected by mental illness; a Duke Energy Grant to establish racial and sensitivity training; and The Brayton Family Scholarship for students enrolled in programs related to the Biotechnology Center of Excellence (BCOE).

Additionally, the capital campaign to purchase state-of-the-art equipment for the new Biotechnology Center of Excellence is going strong with solid community support. This building will be a centerpiece for Alamance County as it attracts new manufacturing businesses, and provides biosciences education unique to this area for students throughout the Piedmont and Triangle areas of North Carolina.

We have been humbled by the generosity of our individual and business donors as we continue to meet the challenges of a new reality. With your support and partnership, the ACC Foundation will continue to support classic programming, identify new opportunities, and help maintain progress at ACC and in our community.

Continuing a goal of modernization that began with the opening of the Advanced Applied Technology Center in 2017, Alamance Community College in 2021 began in earnest its commitment to the promise of the College Facilities Capital Plan, funded by both the voter-approved \$39 million capital construction bond and the County Capital Reserve Funds approved by the Board of Commissioners.

The construction, renovation and expansion projects underway this year represent the promise of the Board of Trustees and school administrators to move Alamance Community College toward center stage as a 21st century college campus in an effort to undergird the workforce demands of the future.

Look now over the following pages to see how the College is using its public funding wisely and prudently to bring the best possible facilities to its campus—the most expansive capital construction initiatives since ACC made its home on this location back in 1976.

Biotechnology Center of Excellence

■ Project Budget: \$19,460,430

■ 32,041 square feet

■ Construction started: September 2021

■ Construction completed: December 2022

ABOUT THE PROJECT: The Biotechnology Center of Excellence, when completed in late 2022, will be a highly visible freestanding, three-story, 30,000+ square foot structure, hosting a mix of labs and classroom space serving the Biotechnology, Medical Laboratory Technology, Histotechnology and Agricultural-Biotechnology programs.

The Center is designed to include space for start-up and early stage biopharma companies. The building's highly visible location along I-85/40 will provide indoor/outdoor learning spaces that align with the needs of students, faculty, and industry partners.

The Center's mission is to serve as a regional hub for innovative, industry-supported and technology-based workforce development and jobs in the rapidly expanding field of biotechnology that supports the economic vitality of Alamance County.

Alamance Community College is positioned—geographically and strategically—in the middle of North Carolina's most active biotechnology corridor. Indeed, Burlington is the nation's #1 small Metropolitan Statistical Area for research, testing and medical labs.

Student Services Center

■ Project Budget: \$6,703,500

■ 12,203 square feet

■ Construction start: October 2021 ■ Construction complete: October 2022

ABOUT THE PROJECT: The new Student Services Center relocates and enhances space for Admissions, Registrar's Office, Financial Aid, Student Payments, and the Office of the Vice President for Student Success. Included also will be a ground floor multipurpose space that can be subdivided into three meeting areas by use of sliding partitions. Upon completion, it will serve as the new entrance to the campus core facing Jimmie Kerr Road.

Culinary Expansion and Renovation

■ Project Budget: \$1,100,000

■ Construction completed: August 2021

ABOUT THE PROJECT: The Culinary Arts Expansion Project, which began in early 2021, was completed in mid-June. That project entailed renovating approximately 5,000 gross square feet of existing classroom space into a specialized production kitchen and adjoining dining hall that simulates the preparation and serving environments students will experience when they enter the workforce. Culinary Arts students now have a teaching/serving facility that replicates the venues in which they will work as chefs such as fine dining establishments, country clubs, and banquet halls.


Old Shop Building Renovation for Horticulture and Animal Care

■ Project Budget: \$5,000,339

ABOUT THE PHASE 1 PROJECT: Upon the move in 2017 by the Welding and Automotive Systems programs to the Advanced Applied Technology Center, the vacant shop facility provided a keen opportunity for major renovation and expansion. The reimagined space allows additional classrooms for the award-winning Horticulture Technology program, and a new home for Animal Care and Management. The space was renovated throughout 2021 and completed last September.

Cosmetology Upgrades

- Moved Esthetics to a larger classroom. The program merged two rooms in order to accommodate the increased number of students enrolled to a more spacious area to adhere to social distancing requirements.
- Made the classroom vacated by Esthetics into a larger space to accommodate the increased student population to adhere to social distancing requirements.
- The Cosmetology department has increased enrollment and still needs more space to accommodate current and future students.

Early College and Campus Dining/ **Commons**

ABOUT THE PHASE 2 PROJECT: Underway in summer 2021, the ABSS Early College and Campus Dining/Commons are projected to be completed in early

2022. With the EMS program vacating the first floor of the campus B-Building, a major overhaul of that space will provide an optimal learning environment for the Early College. The reimagining of the Dining/Commons area in the main building allows students to socialize, study, and dine in an innovative space more conducive to students' needs.



Work on the student commons/dining area will be completed in early 2022.



Emergency Medical Services (EMS) Renovation & Expansion

- Project: \$335,600 (County Capital Reserve funds)
- Construction completed: August 2021

ABOUT THE PROJECT: As part of the overall College Facilities Capital Plan, a new dedicated location for the Emergency Medical Services (EMS) program was initiated in summer 2021, giving it an additional 190 square feet. Approximately 6,800 square feet of general classrooms were transformed into EMS multi-skills labs and high-fidelity simulation space to include a fully functional emergency room, one-bedroom residential apartment, and mock ambulance. With the integration of high-fidelity simulation into the EMS curriculum and upgraded facility technology capabilities, the program is better positioned to develop critical thinking and mentally resilient graduates. Additionally, the College was awarded a USDA grant last year to fund technology design and integration that will allow the EMS program to communicate directly with area fire departments as part of EMS training.

Technology Infrastructure a Priority

Technology infrastructure took center stage in 2020-21 as the College's Information Technology department answered the call to fulfill technology needs campus-wide.

The 32 infrastructure initiatives implemented included these key projects:

- Increased remote working capability for all approved faculty/staff teleworking from home during pandemic
- Initiated and assisted implementation of 25Live Room Scheduling project, a system that simplifies scheduling tasks, from quick room searches and requests to the most complex scheduling and publishing projects
- Assisted college department heads to plan and upgrade ACC computer classrooms
- Initiated an E-Commerce solution that will allow Continuing Education students to register and pay for classes online
- Assisted with TimeClock Plus implementation replaces legacy system to allow employees to enter time and leave from their mobile devices
- Migrated our Student Information System to the AWS
- Upgraded Campus Wi-Fi to a new Enterprise-level system
- Migrated employees from GroupWise to Google Gmail
- Coordinated information technology (IT) needs for EMS and Nursing simulation projects
- Initiated a Gmail FAQ page on college website for ACC users


College Awarded \$20,563,000 in Grants Between 2019-2021

Alamance Community College has been the recipient of \$20.5 million in state, federal and independent grants since July 2019-a game-changing linchpin in the institution's ability to

push forward on important, student-oriented programs and equipment that are crucial to implementing high educational and jobtraining initiatives for Alamance County students.

\$1.1 Million Federal Grant Benefits Biotech Programs

The College was awarded a \$1.1 million federal grant from the Economic Development Administration (EDA) to help purchase hightech equipment for the future Biotechnology Center of Excellence that will provide crucial training for students and workers in biotechnology-related programs.

The equipment will be used to train ACC students in Biotechnology, Histotechnology, Medical Laboratory Technology, and Agricultural-Biotechnology. In addition, current workers in the medical, healthcare, and bio agriculture industries will utilize the equipment for ad-

vanced training. It will expand the College's current efforts to help the healthcare industry fight the coronavirus pandemic and any future health crises.

With the purchase of this critical training equipment, the medical testing, health care, and agriculture industries will see increased opportunities to prosper. Labcorp, a leading global life sciences company and major employer in Alamance County, and Cone Health Alamance Regional Medical Center in Burlington have each committed to creating new high-wage and high-skilled jobs in support of the EDA grant.

ACC Awarded Golden LEAF Grant

The Golden LEAF Foundation awarded ACC \$195,000 to purchase three bioprocessing machines to train students for openings in the biotech, lab and pharmaceutical industry and help meet the demand for more than 200 open positions.

The equipment will be installed in the new Biotechnology Center of Excellence facility that will open to students and industry partners in late fall 2022.

Golden LEAF's Open Grants Program bolsters economic development projects in the areas of job creation and economic investment; workforce preparedness; agriculture; and community competitiveness, capacity and vitality.

Longleaf Commitment Grant Covers Tuition for 2021 HS Graduates

The Longleaf Commitment Grant provided a path for 2021 high school graduates enrolling at ACC to persist, complete, and achieve their academic goals by covering their tuition and fees for up to two years.

The grant—not a loan—provided students attending any one of the state's 58 community colleges with \$700 to \$2,800 per academic year depending on their family's financial situation.

Longleaf's goal was to provide an opportunity for recent high school students to graduate from college debt-free with a degree that allows them to be employed in high-demand professions.

The Longleaf Commitment Grant, which ends at the conclusion of the 2023 spring semester, included those in Career & College Promise (CCP) and Early College. Students enrolled in a high school in fall 2021 were also eligible.

Early Childhood Program Benefits from \$750,000 Federal Grant

ACC was one of only three two-year schools in North Carolina whose Early Childhood Education program was invited to participate in a national project to better prepare early childhood education professionals.

The project, SCRIPT-NC (Supporting Change and Reform In Preservice Teaching in North Carolina), is supported by a \$750,000 grant from the U.S. Department of Education's Office of Special Education and Rehabilitative Services. It focuses resources on helping early childhood professionals with associate degrees to better meet the needs of young children, including children with diverse cultures, languages, and abilities.

UNC's Frank Porter Graham Child Development Institute provides experts to work with ACC Early Childhood faculty on the program.

"This will support, enrich, and help mold our future leaders in education." This project will help us ensure we are preparing our graduates with the most

up to date crucial knowledge and tools needed to successfully meet the needs of all children, families, and their communities," said Kristina Ketcham, Department Head of the Early Childhood Education program.



Grant Will Bridge Gap Between Telemedicine and Education



The College received a \$892,000 U.S. Department of Agriculture grant to create a network link between the campus and local Emergency Medical Service (EMS) stations that will bridge the gap between telemedicine and higher education.

The College will utilize the existing WE-HELP Initiative (Web Enhanced Healthcare Education Linking rural communities Program) to leverage video-conferencing technology to create a virtual network among 20 Alamance County first-responder bases such as fire departments and EMS stations. The result is the delivery of educational programming to over 600 first responders and essential healthcare workers and students.

ACC's own Nursing and EMS instructors will deliver the instruction from the network hub located on the college campus and administered by the Distance Learning department.

The network will include virtual meeting and classroom technology at 20 EMS stations across Alamance County. Firefighters, for example, will learn how to manage patient overdoses as demonstrated on robotic mannequins by nursing instructors at ACC.

Federal TRIO Grant Augments Student Support Services

TRIO is designed to provide low-income, first-generation, and disabled students with support services that will allow them to achieve their academic and career goals.

During 2020-2021, TRIO Student Support Services provided support services for 133 students. Last year, 86% of program participants received the federal Pell Grant and 71% of TRIO students were first generation scholars. Students with disabilities made up 15% of the program's initial cohort of students.

"Starting a brand new program during a pandemic has been a challenge. Finding creative ways to engage students and partnering with faculty and staff has been key to meeting our numbers during this first year," said Shawn Guy, Director of TRIO Student Support Services.

Among TRIO initiatives last year:

- Virtual college tours and online contests helped to peak students' interests
- Partnered with organizations such as The Center for Creative Leadership, College Foundation of NC (CFNC) and the International Civil Rights Museum
- The Center for Creative Leadership produced Stepping Up to Conflict, a leadership curriculum that TRIO infused into its programming
- CFNC conducted several financial literacy workshops
- TRIO students had opportunities to take a virtual tour of Greensboro's International Civil Rights Museum

- 86% of program participants received the federal Pell Grant.
- 71% of TRIO students were first generation scholars.
- Students with disabilities made up 15% of the program's initial cohort of students.

Active TRIO participants have the opportunity to qualify for the TRIO Student Access Grant. To date, The TRIO Student Support Office has assisted more than 20 students by locating more than \$14,000 in scholarship assistance.

The program in early fall 2021 took a group of students to UNC Charlotte for a college tour, and scheduled another to Appalachian State University.

"Building this program has been a very rewarding experience," said Guy. "Seeing students grow academically and personally in just a few months has me excited for what the future may hold for TRIO Student Support Services at Alamance Community College."

ACC Creates Pathway for Young Women in Engineering Careers

ACC used a \$99,600 National Science Foundation (NSF) grant to create a partnership and pipeline to steer young girls toward the engineering career field.

Women in a Network of Discovery (WIND) is the future educational pathway aimed at increasing the number of women, especially minority and low-income females, earning associate and bachelor's engineering degrees.

ACC's leadership role in the WIND partnership will create a plan for engineering educational pathways from third grade to a college degree. The plan is ambitious, bringing together a coalition of the Alamance-Burlington School System (ABSS), NC State University, and Elon University.

The WIND initiative will be characterized by experiential learning, makerspace involvement, summer camps, mentoring, family education, year-round activities on Saturdays, peer networks, paid internships, and other support activities.

In addition to the partnership among educational institutions, a planning team headed by ACC Executive Vice President Connie Wolfe will create an advising committee to include representatives of engineering companies, local government, and engineering societies, most notably the Society of Women Engineers and Women in Engineering.

The goal is to ensure the next-generation technical workforce is diverse and has the needed skills and talent for the 21st century.

ACC, Elon, and ABSS Partner on **Alamance Scholars Program**

Alamance Community College, Elon University, and the Alamance Burlington School System (ABSS) signed the Alamance Scholars Program in January

2021 to develop an initiative to address the shortage of teachers in the local schools and to enhance the racial and ethnic diversity of educators in area classrooms.

Alamance Scholars provides a pathway for students to pursue careers in teaching, guiding and supporting them from high school to an associate's degree

at ACC, and on to a bachelor's degree at Elon. Alamance Scholars will be guaranteed employment within the Alamance Burlington School System.

"It's an exciting opportunity for students from Alamance County to start here, learn here and teach here," said Dr. Gatewood.

Starting in fall 2021, high school students began as members of a new ABSS Teacher Cadet Program, where they will spend time in several classrooms observing and learning about teaching from current educators.

ACC, Elon Collaborate on Service Learning Initiative

ACC is among several organizations named to partner with Elon University in an initiative that organizes service learning opportunities.

The Leaders in Collaborative Services Coordinator (LINCS) program is a two-year effort coordinated through the Kernodle Center for Civic Life at Elon University.

The LINCS program will provide ACC's Academic and Career Readiness department with a ten-hour per week coordinator to organize service learning for between 10-25 Elon University student volunteers. The Elon students will perform active work on the ACC campus that supports student success in the classroom.

This is the second time in about four years that ACC has collaborated with Elon University on this initiative.

"This is just another great partnership among many between Alamance Community College and Elon University," said Jennifer Mock, Director of Academic and Career Readiness at ACC.

ACC Partners with Lees-McRae College for Guaranteed Admission, **Scholarships**

ACC partnered with Lees-McRae College in a guaranteed admission program beginning with spring 2021 semester, which provides more opportunities for ACC students to pursue a four-year degree. This agreement includes Lees-McRae's online degree programs in Business Administration, Criminal Justice, and Human Services, allowing students to remain at home while earning a baccalaureate

ACC graduates are accepted to Lees-McRae College if they first earn an associate's degree and maintain at least a 2.5 GPA while at ACC.

The ACC transfer students also can receive merit-based academic scholarships and are guaranteed for the duration of the student's stay at Lees-McRae as long as the student remains in good academic standing. New Horizon Transfer Scholarships are awarded to students based upon their academic performance at ACC prior to enrolling at Lees-McRae College.

The Guaranteed Admission Program with Lees-McRae is the latest transfer agreement that ACC has offered to its students through partnerships with other North Carolina institutions of higher learning. Other agreements of recent years include those with Elon University, UNC-Wilmington, NC State, NC Central, and UNC-Greensboro.

ACC Approved as **NC** Apprenticeship **Sponsor**

ACC was approved as an official apprenticeship sponsor through the auspices of ApprenticeshipNC, the state agency that oversees apprenticeships in North Carolina. The College is registered with the state and the U.S. Department of Labor through ApprenticeshipNC.

The designation means the College assumes the responsibilities previously performed by businesses interested in having student apprentices, but which required many man-hours of work. This includes contact with ApprenticeshipNC, registration of pre-apprentices and apprentices, documentation of related education and on-thejob training hours, and checking acquired competencies regularly.

For ACC, it means becoming a conduit for recruiting more students to the college.

In the future, ACC plans to offer summer pre-apprenticeship programs where students can learn basic skills in a trade. During their pre-apprenticeship, companies can observe the development of these students and hire them into the apprenticeship program.

ACC became an apprenticeship sponsor on the heels of already enjoying a successful partnership with the Career Accelerator Program (CAP) since 2016. CAP is a four-year apprenticeship in Machining, Mechatronics or Industrial Systems in cooperation with ten local companies.

First Seven Apprentices Graduate from **Career Accelerator Program**

The Alamance Career Accelerator Program graduated seven apprentices from its first cohort that began in 2016 at a ceremony held at the College in summer 2021.

The Career Accelerator Program (CAP) is designed for high school juniors and seniors who can earn money on the job as soon as they start the apprenticeship program while also taking college classes. It is a partnership between Alamance Community College, Alamance-Burlington Schools, and 12 industrial businesses in Alamance County.

The CAP graduates completed approximately 8,000 hours, comprised of 6,400 hours working as apprentices and 1,600 hours learning in class. Apprentices have grown by about 80% since Apprenticeship NC began partnering with the NC Community College System in 2016.

All tuition, books, and fees for the associate's degree program are covered, and students graduate debt-free. Apprentices earn an Associate of Applied Science (AAS) from ACC and have the option to transfer degree credits to most NC universities. The students also earn specialized certification and experience that is recognized and sought by employers. A new cohort of apprentices has been initiated each year in Alamance County since 2016.

Alamance CAP is recognized by the State of North Carolina as a registered apprenticeship program.



Two More ACC Students Begin **Industry Apprenticeships**

Two Alamance Community College students, accepted into the sixth Career Accelerator Program (CAP) class, signed formal agreements in August 2021 with NC Works to begin working part-time as apprentices while continuing their studies at ACC.

The Career Accelerator Program (CAP) is a partnership of the College and Alamance-Burlington Schools, the Alamance County Area Chamber of Commerce, and eight local manufacturing-based companies.

The criteria for acceptance for the students included visiting companies, meeting academic and attendance requirements, taking two classes at ACC, and working for six weeks as an intern in summer 2021.

The selection process is extensive to ensure companies and students are a good match because money investments are significant over the four-year period. The apprenticeship provides the students the opportunity to earn while they learn and the companies benefit by training and developing an employee to meet specific needs of their workforce.

Tuition and books at ACC are paid for by the company. At the end of the four years, an apprentice will have an Associate of Applied Science degree in either Mechatronics Technology or Mechanical Engineering Technology; a Journeyman Certificate from the N.C. Department of Commerce; 6,400 hours of on-the-job training; a guaranteed job with the company; and no school debt.

Jose Santos is an apprentice at AKG, Inc. He is the company's fourth apprentice through CAP. Parker Duggins is an apprentice at Elevate Textiles, a new industry partner in the program.

Jim Bryan, president of industry partner Fairystone Fabrics, serves as chair of the Career Accelerator Program in Alamance County. He said the goal is to add many more industry partners.

2021 ACC Graduate Credits Apprenticeship with Fast-Tracking His Career

Jace Walker, a 2021 ACC graduate, knows his decision to enroll at ACC while simultaneously applying for a Career Accelerator Program apprenticeship sealed his future at a young age.

Jace became the first apprentice at Engineered Controls International, LLC in Whitsett to complete the Career Accelerator Program (CAP) by earning his associate degree.

Jace graduated with an Associate in Applied Science degree in Mechatronics Engineering Technology while working an apprenticeship that also provides him with a Journeyman's Certificate from the N.C. Department of Commerce.

Jace is one of many ACC students who have benefited from this initiative in which local industries have partnered with ACC to offer apprenticeships. As a win-win initiative, companies have an opportunity to develop talent for needed positions and students can earn while they learn and start good-paying, strategic careers.

The Career Accelerator Program is a partnership program between the Alamance-Burlington School System, Alamance Community College, the Alamance County Area Chamber of Commerce and local manufacturing companies.

Jace enrolled in ACC's Mechatronics Engineering Technology program because he knew it was a good-paying field in which he could find a job by age 21. Paired with his apprenticeship as a member of the maintenance team at RegO's Rock Creek facility in Whitsett, Jace spent one year in the department developing his mechanical, electrical, and troubleshooting skills. A transfer opportunity allowed him to join the automation group at the Rock Creek facility.

Said Bill Holt, New Program/Automation Manager: "From the day that Jace started in the automation group, he has been a top performer and a key contributor. From a company perspective, Jace has exceeded expectations and the Career Accelerator Program has absolutely delivered to its goals."

ACC Honors 789 Graduates at **Virtual Commencement**

The College conferred degrees, diplomas and certificates on 789 graduates in May 2021, a total that represents 685 Curriculum (degrees/diplomas/certificates), 80 GED/HiSet, and 24 Adult High School students.

For the second consecutive year, a virtual ceremony replaced the traditional on-site event due to COVID-19 social distancing restrictions.

Some highlights:

- The College conferred credentials on 105 high school students taking college credit classes through the free Career and College Promise (CCP) program.
- 208 received Honors and 123 earned High Honors among the total curriculum graduates.
- 15 GED/HiSet students earned Honors.

Associate Degree in Nursing Pinning Ceremony

Twenty nursing graduates received pins signifying completion of their training prior to becoming Registered Nurses last May. The Associate Degree in Nursing department held an in-person outdoors pinning ceremony on campus. The College's new policy allowing individuals to be maskless outside allowed nursing graduates and their families to watch from lawn chairs.


College Continues Service, Protocols During COVID-19

With the full return to campus of masked students, faculty and staff in August 2021, the College touted its successful campaign in keeping the campus safe from the spread of COVID-19. No clusters were reported at ACC since the pandemic began, allowing for the gradual return to normalcy at all campuses in 2021 through adherence to safety protocols.

In conjunction with the Alamance County Health Department, the College scheduled nasal swab testing sessions and vaccination clinics.

Communication channels included Zoom conference calls with staff and faculty in which administrators answered COVID-related questions from employees, clarified protocols and processes, and mitigated anxiety and concerns.

Overall, the College has implemented dozens of protocols to create a bubble and mitigate viral spread. These include:



- More than two dozen PPE stations across both campuses, dispensing gloves, masks and disinfectant
- Nearly a dozen self-temperature checks across the campuses
- ACC Safe app for classroom entry, which confirms that a student is healthy
- The SlowCovidNC app for exposure detection, which detects if a nearby individual has registered as COVID-positive
- Continued deep cleanings across campuses, particularly in high interaction areas
- Majority of instruction delivered online from March 2020 to summer 2021
- Hiring a Health Educator to provide counseling and facilitate access to resources
- Employment of virtual meetings wherever possible
- Weekly online updates on the pandemic for employees and students by ACC President Dr. Algie Gatewood

College Meets Challenge of Diversity for All on Campus

With civil rights protests and challenges erupting across the U.S. over the past year, the College embarked on an initiative to provide all students, faculty, and staff with equal opportunities to access educational and support needs. The Board of Trustees in August 2020 unanimously adopted a Resolution to Promote Diversity, Inclusiveness, and Racial Justice within the Context of Higher Education and to Combat Forces that Foster Systemic Racism. The Resolution encouraged the College to form a Racial Equity Commission.

In fall 2020, ACC President Algie Gatewood worked with college leaders to assemble a commission with diverse membership. The 23-member College Commission on Race, Equity, Diversity, and Inclusion (REDI) met to discuss goals. A new position for Director of Diversity and Inclusion was created and filled.

As the College develops a new Strategic Plan, diversity and equity will take a prominent role. ACC's diversity work will not be limited to race and ethnicity, but will also include disability, gender, age, and income.

Geriatric Simulator Teaches Empathy to ACC's Nurse Aide Students

Young students in ACC's Nurse Aide program are finding a unique way to better empathize with their elderly patients, thanks to special equipment purchased from federal funding provided by The Coronavirus Aid, Relief, and Economic Security (CARES) Act.

Since Nurse Aide students were unable last year to participate in clinicals at nursing homes due to the coronavirus, geriatric simulator equipment helped the students learn.

The RealCare™ Geriatric Simulator includes a sensitivity suit and complete curriculum to help participants understand the common physical effects of aging. Included in each kit is a weight vest, cervical collar, wrist weights, elbow restraints, ankle weights, knee restraints, gloves, and visual impairment glasses—all engineered to simulate a variety of ailments common to the elderly.



"One thing we miss out on in clinicals is discovering what it's like for actual patients," said student Logan Hadley. "Going through this experience lets us know what they [the elderly] need."

Department Head Rhonda Pierce said that

Former Pro Athletes Trade in Sneakers for BLET Training

ACC has two former professional athletes in the current Basic Law Enforcement Training (BLET) class. Former Seattle Seahawk Michael Brooks and former European League player Lamont Hamilton have traded in their cleats and sneakers, respectively, to become law enforcement officers in a career move that speaks volumes about their commitment to public service.

From NFL to BLET at ACC

Yanceyville native Brooks excelled on the football field at East Carolina University where he played from 2009-2012 and recorded 52 solo tackles and 10 sacks. Soon the NFL loomed.

Signed by the Seattle Seahawks, Brooks joined the team for quarterback Russell Wilson's first full season as starter. That season the Seahawks won their first Super Bowl, defeating the Denver Broncos. Ultimately, injuries played a major role in Brooks' transition from the NFL to the Canadian Football League (CFL) where he played from 2015-2018.

"I always had a plan to leave professional sports by the time I was thirty," said Brooks. "I was at peace with my decision and happy to start this next chapter in my life."

Brooks had earned a bachelor's degree in criminal justice while at East Carolina. Once his football career ended, Brooks settled in Raleigh and studied his options of where to enroll in a BLET program.

"I knew how prestigious the program at Alamance Community College was, and I wanted to learn from the best to be one of the best," said Brooks.

After completing BLET and getting to work at the local law enforcement level, Michael Brooks said he hopes to one day work at the federal level to help people worldwide.

Former Professional Basketball Stalwart Trains for BLET

For basketball stalwart Lamont "Monty" Hamilton, his journey toward professional sports began in the projects in his native Brooklyn, NY. He persevered, found his talents lay in playing basketball, and received a full scholarship to play at St. John's University. By his senior year, Hamilton was named to the All-Big East Conference First Team in 2007.

But Hamilton went down with a knee injury his senior year that kept him away from the important summer league camps. When the NBA failed to draft him, he found a fresh opportunity to play in the European League. He ultimately played for teams in Spain, France, Russia, Turkey, and Japan for 13 years.

It was ultimately the COVID-19 pandemic and a hiring freeze overseas that forced Hamilton to reevaluate what he wanted in his life.

"It was time to think of what came next and what type of career I wanted to have. Law enforcement has always been on my list and I knew I wanted to help change the narrative surrounding law enforcement today," he said.

With his training in BLET at ACC this year, Hamilton knows he has what it takes to persevere through new experiences to become successful.

"I look forward to affecting change, building community and learning how to be a leader in a new profession," he said. "I look forward to the day when people look up at me and call me 'detective."

ACC 2020 Graduate Heads to **Georgetown University**

For Diana Quintanilla, a 2020 Alamance Community College alumna, the road to making her mark in the world was fraught with difficulties. But fall 2020 found her as a member of the Georgetown University Class of 2024. She worked hard to get there. As a Career and College Promise student at ACC, Diana also was named the 2020 valedictorian at Cummings High School in Burlington.

Diana is the latest among several Alamance Community College graduates who have been accepted to prestigious higher institutions in the past few years, including Duke University, M.I.T., and the UNC Kenan-Flagler Business School.

Diana Quintanilla, an El Salvador native, rarely heard any English spoken until age four because her mother only spoke Spanish. By the time she began school in Alamance County, she still only spoke her native language. But her teacher helped assimilate Diana as she slowly began to learn

Diana struggled with reading and writing English while in elementary school. By the time she entered middle school, however, she began reading more which improved her linguistic skills. Sixth grade was a time for Diana to reinvent herself. She loved the teachers who challenged her and she joined the school orchestra. By seventh grade, she placed in advanced

classes, fell in love with reading, and discovered her writing skills. She finished middle school on the honor roll for three years in a row, and entered high school as a girl on a mission.

"I have always lived in a society where I am constantly considered a statistic rather than an individual, and I didn't want to be that anymore," says Diana. "I wanted to be the exception to the rule, I wanted to skew the data. I wanted to show the world something different. So I knew that I needed to stand out in my college application."

She was accepted to the Elon Academy summer program, a selective college access initiative for academically promising students who are underrepresented on a college campus. She became a leader at Cummings High, a National Honor Society scholar, and the president of multiple high school clubs.

Then Diana discovered Alamance Community College and its unique and cost-cutting Career and College Promise (CCP) program. CCP is a free initiative courtesy of the NC Community College System that allows high school students

to earn multiple hours of college credit by taking courses at the local community college while still matriculating through high school.

Then came the idea of a Georgetown University education. Confident about her grades—she ultimately graduated Cummings with a GPA of 4.546—she researched the possibility of attending Georgetown and found that it offered her

ideal course of study, Global Health, a program housed in the School of Nursing & Human Science (NHS).

Fortunately, Georgetown met her family's financial need 100 percent. She also received the Community Scholars Program and the Georgetown Scholars Program, both dedicated to serving low income and first generation college students.

Like most other college campuses last fall, the pandemic forced Diana to start her academic career online; still, she enjoyed her studies as a member of the Georgetown class of 2024.

"In the long run, I would like to attend graduate school and work for a non-profit," says Diana. "All with the mindset of paying it forward and making those who have supported me—family, teachers, mentors, and friends—very proud and making my mother's sacrifice worth it. Because as my mother likes to say, Todo sacrificio tiene su recompensa," which means Every sacrifice has its reward."

ACC Alumna Admitted to Elon Law School at Age 19

Mary Spektor, an alumna of Alamance Community College and University of North Carolina, found herself this fall enrolled at Elon University School of Law at age 19. She completed this feat by sheer determination and grit, and with a firm vision from a young age of what she wanted to accomplish.

Mary Anna Spektor is the child of immigrants from Ukraine. The family moved from New York to Burlington, NC five years ago and a counselor at Western Alamance High School recommended the academically high achieving student take college-level credit classes at Alamance Community College for the remainder of her high school career. Mary and her parents learned about ACC's popular and free Career and College Promise program, a state initiative that allows high school students to earn free college credits.

Mary realized she should take advantage of anything available that would help her move closer to her college and career goals; therefore, she applied to and was accepted into the Carolina Student Transfer Excellence Program, better known as CSTEP. The program guarantees admission to UNC-Chapel Hill for qualified community college students

with the stipulation that they participate in developmental and cultural events both at ACC and UNC.

It was the Mock Trial Team at ACC that provided Mary an opportunity to deepen her love for the legal career she dreamed about. She was elected president of the Mock Trial Team and took on additional responsibilities that included helping to prepare her fellow team members for competition against four-year schools.

Mary excelled in the CSTEP and CAP program at ACC, becoming the first Western Alamance High student to complete 60 college credits at age 17 to earn a full Associate in Arts degree that guaranteed her full junior class status when she transferred to UNC-Chapel Hill.

Mary soon began the lengthy process of applying to Elon's law school as she double-majored in History and Philosophy at UNC.

In February 2021, Mary received the most important and exciting email in her young life: an acceptance from Elon University School of Law for the fall 2021 term.

As Mary began her first year of law school this fall, her plan was to work toward a career in civil litigation and specializing in family law and injury claims. Because Elon's law school program is two and a half years long—rather than the traditional three years at most law schools—Mary hopes to get her career underway by age 22.

ACC Named Center of Academic Excellence in Cyber Defense

The College's Associate in Applied Science degree in Information Technology-Systems Security (Cybersecurity) was officially designated a National Centers of Academic Excellence in Cyber Defense (CAE-CD) program of study in 2020.

Educational institutions receive the CAE-CD designation only after meeting a rigorous set of requirements established by the National Security Agency (NSA) and the Department of Homeland Security (DHS).

The standards set forth by the NSA/DHS curriculum guidelines ensure that students from CAE institutions, such as ACC, receive a quality and robust cybersecurity education that prepares them for a career in the cyber workforce.

ACC earned this designation based on its robust degree program and the close alignment of curricula components to specific cybersecurity-related knowledge units. This alignment is validated by top subject matter experts in the cyber field.

Elon University Named 2020 Business Partner of Year

Elon University earned accolades as the College's 2020 Business Partner of the Year in recognition of the outstanding support the university has consistently provided to ACC students and graduates.

Among the partnerships are: a 2016 agreement guarantees that qualified ACC students can seamlessly transfer up to 65 credits to achieve full status as juniors at Elon; the Elon Transfer Scholarship grants \$22,500 annually for up to three years to a selected ACC graduate toward the cost of tuition, fees, room and board; ACC, Elon and ABSS signed in early 2021 the Alamance Scholars Agreement, a specialized 2-plus-2 teacher transfer agreement that benefits local high school students; Elon University contributes 20 to 30 student learning interns per semester through the Kernodle Center for Civic Engagement to ACC's Academic and Career Readiness (adult literacy) students; Elon Academy high school students attend ACC as Career and College Promise students, earning free college credit in ACC classes; Elon University consults with ACC's Academic and Career Readiness staff to improve instructional delivery in the English for Speakers of Other Languages (ESOL) program; and Elon University, the Oak Foundation and the Village Project provided ACC with grant funds and

VIQTORY, a service-disabled, veteran-owned small business surveyed over 1,200 schools and 747 earned the "Military Friendly" designation.

The Military Spouse Friendly Schools designation helps military spouses select schools that will support them in their education journey by meeting their needs as a part of a military family. Schools that are selected for the list are at the forefront of supporting the goals of military spouses.

Among ACC's benefits to military veterans are:

- ACC designates priority class registration for veterans.
- ACC offers designated Military Veteran parking spaces that are painted red, white, and blue.
- A licensed Veterans Center counselor is available once a month for confidential counseling.
- The Mobile Veteran Center comes to ACC main campus once a month for counseling and general questions.
- The College provides Green Zone training (professional development) for faculty and staff who wish to learn more about the military-affiliated student experience.
- The Veterans Association Club provides a network of support to military veterans, their families and civilian supporters. The club recently become a chapter member of Student Veterans of America.
- Feleta Morton, VA Coordinator at Alamance Community College, currently serves as President of the NC Association of Coordinators of Veterans Affairs, of which ACC is a member.
- ACC is also a member of the National Association of Veteran Program Administration (NAVPA). Feleta Morton is an elected member of the Regional Board.

Pruitt believes in crossover teaching by taking the students out of the classroom clinic: traveling to dental offices for training in new hands-on technology; and visiting dental labs to better understand processes. A strong believer in classroom collaboration, she says group projects and exercises build leaders which is fundamental in a dental office. Her students also participate in community dental health initiatives. Said Pruitt: "Training, educating, and instructing students to become great employees for our community has always been the driving force behind what I do."



ADJUNCT FACULTY MEMBER OF THE YEAR

Valerie Whitley, CIT Instructor

Valerie Whitley, an ACC graduate, taught Computer Information Technology (CIT) as an adjunct instructor from 2012-2021. A graduate of UNC-Greensboro, she also tutored and served as office manager in ACC's Academic Skills Lab for 15 years. Whitley has an M.Ed. in Educational Technology and used her expertise to create student-centric master Moodle templates, still used in all basic Computer Information Technology classes at ACC. Despite working a full-time firstshift job, Whitley is committed to her students' learning and needs. "Everything I do for ACC is because I love what I do," she said.



STAFF MEMBER OF THE YEAR

David Prevatte, Director of Public Safety

Chief David Prevatte, ACC's Director of Public Safety from 2016-2021, is a 28-year law enforcement veteran with both bachelor and master degrees in the criminal justice field. Chief Prevatte dedicated his time at ACC to transforming the department into a robust team that included personnel with experience in law enforcement at the civic level. Under Chief Prevatte, ACC's Department of Public Safety engaged in partnerships with area law enforcement agencies for emergency management training, including multiple active shooter drills on the College's two campuses. Chief Prevatte's plan to improve ACC's telecommunications services included training for some college staff in emergency notification software tools.

ACC STUDENT HONORED FOR COMMUNITY SERVICE

Student Jennifer Furman received the Community Impact Student Award from the North Carolina Campus Compact, a statewide network of colleges and universities that is committed to community engagement. The award recognizes students with a deep commitment to community involvement and ability to inspire peers.

As a second year student studying Horticulture Technology, Furman was recognized as a positive role model to other students and a strong member of ACC's National Collegiate Landscape Competition team. She exemplified strong skills as a female in a predominantly male industry.

As a student worker, she managed ACC's 47-acre farm and greenhouses, as well as trained and mentored other student workers. She also volunteered as a 4-H Group Leadership Assistant.

Furman is also an instructor with the Career College Program, teaching students with varying disabilities horticulture industry skills that are needed to secure employment.



TEEN EXCELS IN NATIONAL CYBER LEAGUE COMPETITION

Jessica Frank, 17, a System Security student at ACC, performed in the top ten percent nationwide of the National Cyber League Spring 2021 Individual Games.

The NCL Scouting Report placed Jessica in the 94th percentile among 4,180 participants. The virtual games were conducted in real-time for students across the U.S. last spring. Competitors ranged from high school students to graduate students at prestigious universities. NCL reported that 520 two-year schools and universities from across all 50 states registered to play.

The NCL Scouting Reports, in which Jessica Frank excelled, are recognized by prospective employers as the equivalent of an internship or fulfillment of a contract-based work engagement. Jessica Frank, a dual-enrollment student at ACC, is also homeschooled in Elon.

In 2018, ACC transformed its AAS degree in IT Networking to one that focuses on the broader information security needs in the modern organization.

ACC Students Shine in 'Virtual' National Collegiate **Landscape Competition**

ACC's Horticulture Technology students excelled in the 2021 National Collegiate Landscape Competition last spring, a virtual event sponsored by the National Association of Landscape Professionals.

ACC sponsored 14 students in workshops, career fair interviews, and competitions. In all, 34 colleges and universities participated, with nearly half representing community or technical colleges.

Among the ACC student competitors, 12 placed in the top ten for their individual challenges. These included Marybeth Krawczyk, who finished 2nd against 75 others in Safety Management; Eric Levine finished 2nd in Business Management

against 43 others; and Jennifer Furman, competing against up to 13 others in her events, finished in the top ten in five events, including 2nd place in 3D Exterior Landscape Design and 3rd place in Computer Aided Landscape Design.

Historically, ACC Horticulture students have excelled at the National Collegiate Landscape Competition when it was held at university campuses across the U.S. Three years ago, ACC hosted the in-person event that brought 63 higher institutions and more than 750 students to its campus.

ALUMNI/STUDENT PROFILE

ACC Student Breaks Gender Barrier

Industrial Technologies student Emily Adkins last year became the first female Maintenance Technician at the RegO facility in nearby Whitsett.

Emily had previously earned an Associate of Arts from ACC in 2015. She was on track to earn her associate degree in Computer-Integrated Machining and expects to complete that in spring 2022. She is also pursuing an associate's degree in Industrial Systems (Maintenance) at ACC.

Emily's journey to breaking barriers began in 2018 when her job introduced her to CNC Machining. Consequently she enrolled in ACC classes to pursue the CNC Machining pathway, looking for a potential career move.

Managers from RegO's Rock Creek facility first met Emily at ACC's "Girls Take Over Tech" event in December 2019, an annual meet and greet that introduces young women to industrial careers.

Said Jeremiah Cornett, Rock Creek Facility Plant Manager: "All of the candidates we saw were impressive, but there was one student who stood out—Emily Adkins. We moved quickly to get her onsite for a tour and interview about her interest in joining us."

One week later, Emily received a job offer and officially joined the Rock Creek production team in February 2020 as a Machine Operator.

Over the past year, Emily was drawn to the Maintenance Department as the career path she wanted to pursue within the company. Working with Maintenance Manager, Jeff Estes, she gained experience using operator precision machines in the company's Hubble Cell. Emily spent one hour a night, at the end of each shift, performing these critical tasks, fueling her desire even more. Due to an opportunity that opened up at Rock Creek, the company moved Emily into the maintenance position in May 2021.

Programs Added Online

During 2020-2021, most of ACC's classesincluding those that had not previously been online—had an online presence at some point due to the need for remote instruction when the COVID-19 pandemic hit in spring 2020. Because of the ability to offer flexible and on-demand instruction, ACC's Distance Learning program has seen an increase in many blended and hybrid courses being offered. The largest increase came in the Applied Engineering, Agriculture, & Skilled Trades programs.

Enrollment Trends

Due to the pandemic's effect on in-person classroom instruction in 2020-2021, the College's online course enrollment saw an overall increase of 146% (including curriculum and continuing education) and 161% increase in curriculum courses alone. In the previous 2019-2020 year, ACC offered 465 fully online sections (E section courses). For the 2020-2021 year, the number of fully online sections increased to 1.245 representing a 168% increase in the numbers of courses offered online.

COVID-19 Impact on Distance Learning

In spring 2020, the College quickly moved all instruction online due to the COVID-19 pandemic. Since then, the department has continued to expand its remote support opportunities for students and faculty by launching two new instructional tools and a quality assurance program for Distance Learning: Mediasite and Proctortrack.

The Mediasite recorder provided desktop capture solutions in a simple and secure way to streamline academic videos. This allowed seamless integration with Moodle and Zoom for lesson videos to be automatically published to create easy access for students.

Proctortrack is an online test proctoring tool, purchased for two years using Covid funds. Proctoring online tests provide faculty an additional layer of support in ensuring academic integrity in online courses. Beginning fall 2021, all fully online courses will require at least one proctored exam.

Last year, ACC joined the NC Community College System's subscription to Quality Matters, a nationally recognized quality assurance program for online programs. During 2020-2021, ACC faculty and staff completed 32 Quality Matters courses. The QM committee is working to develop a plan for campus-wide implementation.



Literacy and Career Education Win Kudos

The College's Academic and Career Readiness (ACR) division recently enjoyed success on three different fronts.

United Way Funds ACR Program at ACC

The ACR division received a \$22,000 grant from United Way of Alamance County to assist adult students returning to school to complete their high school education through test scholarships; provides support for English learners or obtaining citizenship; will help students with learning differences to improve their academics, self-advocacy, and transition.

"This grant will help all students transition to college or a career, and offer support during their journey," said Jennifer Mock, Director of ACC's Academic and Career Readiness division. "This is the fifth year ACC has been awarded this grant and was one of the largest grants to be awarded."

ACC's 'High School Equivalency in the Community' Used Statewide

ACC's High School Equivalency (HSE) in the Community program, a mail-in initiative designed to prepare students for the GED and HiSet tests, was offered statewide for the first time this school year.

ACC developed the HSE in the Community program, which provides access for students via mail-in prep tests. This year, the State of North Carolina adopted ACC's format for its first proxy study in adult education. ACC's Academic and Career Readiness program conducted state webinars to assist colleagues at other campuses.

ESOL Program Awarded \$25,000 to Implement Digital Literacy Skills

ACC was one of nine North Carolina campuses awarded a digital literacy grant to support students enrolled in the English Speakers of Other Languages program.

Students Succeed in Cosmetology and HVAC **Programs for English Language Learners**

Students found success this year in two occupational training programs that are contextualized specifically for English Language Learners. Both Cosmetology and Air Conditioning, Heating, and Refrigeration offered hands-on instruction to students who were also taking English classes specifically designed for each career path. These initiatives are part of ACC's efforts to provide workforce training to our increasingly diverse community.

Cosmetology partnered with Workforce Development cohort. (Academic and Career Readiness) to train students in the Cosmetology Certificate program and the English Language Acquisition (ELA) program. The successful initiative, Integrated English Literacy and Civics Education (IELCE), graduated its first cohort in 2021 and two additional cohorts are already underway.

The IELCE component was facilitated by Victoria Rans, coordinator of the ELA program in Academic and Career


The ACC Foundation assisted with discounted tuition in the Workforce Continuing Education cosmetology sections. Students also received mentoring support and meals from Women United of Alamance County, a United Way program.

ACC also offers an IELCE program in Air Conditioning, Heating, and Refrigeration. These students attend a contextualized English class for four hours on Saturday mornings, followed by four hours of hands-on training on Saturday afternoons. In May 2021, the first cohort of students completed the year-long program and a second cohort began in August.

Corporate Education and Economic Development

Corporate Education provides the business and industry base of Alamance County with a variety of options to satisfy their training goals. Unique programs are offered and customized to meet the needs of a diverse company population.

During the 2020-21 fiscal year Corporate Education division managed 8 Customized Training Projects with a total project budget of \$3,207,610.






ACC's Small Business Center and the Alamance Chamber of Commerce teamed up for a "Business Before Hours" meeting (pre-Covid) in November 2019.

Small Business Center

The Small Business Center (SBC) provides seminars, confidential counseling, employee training, robust resources on business operations and capital formation for existing enterprises and operations to be. It works cooperatively with the Chamber of Commerce, local municipal business corporations, and industry experts.

During the Covid pandemic, the SBC assisted 12 businesses in obtaining a total of \$403,817 in loans through various sources, such as Paycheck Protection Programs, Economic Injury Disaster Loans, Small Business Administration and others.



FINANCIAL AID 2020-21





Total/All Financial Aid: \$9,076,124: 6,723 students helped (duplicated)




Current Fund Revenues: \$44,885,244*



Management



Spending



Ways to Give

General CARES Act Update:

A provision in the CARES Act allows individual taxpayers who use the standard deduction to deduct \$300 for charitable gifts. Taxpayers who file jointly are able to deduct up to \$600. This only applies to gifts made in 2020 and 2021.

Cash:

- Cash gifts are immediate and, if you itemize your taxes, your outright gifts of cash are fully deductible up to 60% of AGI for federal income tax purposes.
- Note: A provision in the CARES Act allows individual taxpayers to deduct cash donations up to 100% of AGI. The limit for businesses increased from 10% to 25% of the business's taxable income. The increase only applies to gifts made in 2020 and 2021.

Appreciated securities:

- A gift of securities can be a good option for accumulated stocks, bonds or mutual funds that have appreciated in value and would be subject to a 15% or 20% (based on tax bracket) capital gains tax if sold.
- Gifting long-term appreciated stock, bonds or mutual funds may offer you two tax savings:
 - 1. You avoid paying capital gains tax on the increase of the value of the securities.
 - 2. You receive a tax deduction for the full fair market value of the securities at the time of donation.

IRAs or Retirement Plan Assets:

- Tax deferred retirement plans represent one of the most significant, yet underutilized potential gift planning assets. Charitable gifts of tax deferred retirement plans escape both estate and income taxation.
- If you are over age $70\frac{1}{2}$, then you can redirect all or a portion of your IRA's Required Minimum Distribution (RMD) to a charity. This is called a Qualified Charitable Distribution. This distribution serves to satisfy all or part of your RMD requirement (RMDs begin at age 72) and prevents the distribution from being taxable. There is a \$100,000 annual limit.

Show your care for current and future ACC students by making an investment today!

■ You could leave 100% or a portion of the tax deferred retirement plan to ACCF. In order to modify your IRA beneficiaries, request a "change of beneficiary" form from your financial advisor.

Bequests:

- After providing for loved ones, you could name ACCF as a beneficiary of a percentage of your assets in your estate planning documents to establish a permanent legacy of helping ACC students. Please consult with your estate planner to implement this strategy.
- In your obituary, you could inform your loved ones you would like ACCF to receive memorial gifts.

Non-Cash Donations and Real Estate:

- ACCF may benefit from donations of non-cash items that help educate students in current techniques and technologies. Examples of such donations include specialized program-related equipment in working order and hands-on training supplies. Such donations may be tax-deductible.
- Outright gifts of real estate allow the donor to avoid capital gains tax and realize a charitable deduction on the full fair market value of the real estate.

Other possible options to discuss with your financial advisor:

- **Life Insurance policies**—request a change of beneficiary form
- Charitable gift annuity—received guaranteed above market rate of return for the remainder of your life
- Charitable remainder trust—at the end of term, remaining assets could be transferred to ACCF.


