

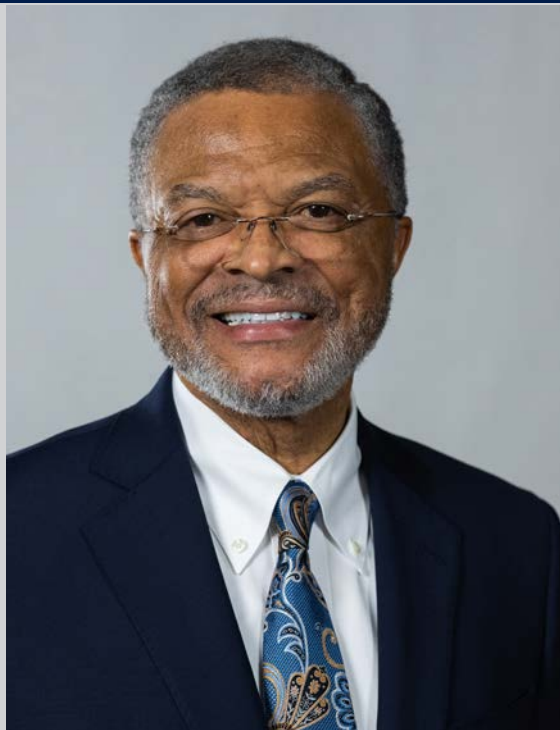

As I set these words to paper in June 2023, just a few weeks before my retirement after almost fifty years in higher education and ten years at the helm of this great community college, I feel bittersweet but immensely proud.

When I look back over my tenure as leader of Alamance Community College, I am astounded by what we were able to accomplish together over the past decade. While there are far too many to mention here, I am proud to have led this institution through these accomplishments:

- Passing a \$39.6 million bond measure with overwhelming voter approval - the largest in ACC's history - that resulted in the construction of three new facilities and countless expansions and renovations.
- Six major multi-million-dollar (\$6.8 million) facility expansions and upgrades: Student Commons cafe area, first-of-its-kind Emergency Medical Services simulation rooms, Animal Science and Horticulture Building, Early College, state-of-the-art Print Shop, and Culinary Arts
- Starting ACC's first Early College in partnership with Alamance-Burlington School System, and enrolling 1,563 students to date
- Establishing 23 transfer articulation agreements that ensure a seamless transition from ACC to a four-year institution
- Adding 19 new curriculum programs since 2013
- Restructuring the College's grants function, resulting in an increase of external grants from \$150,000 to \$25 million since 2020
- Initiating ACC Promise to grant last-dollar scholarships to students who have unmet financial need
- Receiving our first special appropriation in the amount of \$3.8 million in 2022 from the NC General Assembly and poised to receive approximately \$6 million in special appropriations in 2023 for the Public Safety Training Center and Multi-Campus Center
- Developing a 90-plus acre land agreement with Martin Marietta for a modest \$17K per year for 50 years, to build the \$21.3 million Regional Public Safety Training Center
- Acquiring and implementing a variety of special student support and enhancement programs to increase student progression, retention, and graduation rates
- Successfully leading ACC through the Covid-19 pandemic without losing one day of operation

Alas, all good things must come to their conclusion, and my time has come. But not so for Alamance Community College. I am truly grateful for the opportunity to have served as president, and I am confident that the College will continue to thrive under new leadership. I look forward to following this institution's continued success from afar.

Two Capital Projects Open Doors to Students in Spring 2023

Alamance Community College reached a major goal in early 2023 with the completion and opening of two major projects that had been under construction for two years. The College welcomed several hundred guests that included community leaders, elected officials, students and college personnel to a special ribbon-cutting event for the new Biotechnology Center of Excellence and Student Services Center on March 24.

New Biotechnology Center of Excellence Critical to Workforce Development

The \$19.4 million, 32,000 square foot Biotechnology Center of Excellence – the most sophisticated and ambitious capital project in six years – unites and expands five science-based curriculum programs: Biotechnology, Histotechnology, Medical Laboratory Technology, and Agricultural Biotechnology.

The Biotechnology Center expands and enhances ACC's ability to train students and provide a pathway to careers in the biomanufacturing sciences industry. In addition, the facility is expected to serve as a regional hub for innovative, industry-supported and technology-based workforce development and jobs in the rapidly expanding field of biotechnology that supports the economic vitality of Alamance County.

"This project is about more than raising a hammer to build this magnificent facility," said College President Dr. Algie Gatewood. "A Center of Excellence leverages an expertise vital to regional business and industry. A Center of Excellence hosts a unique cluster of programs that are critical to job skills training and workforce development."

Advanced equipment for the Center of Excellence labs was purchased, in part, by donations from individual benefactors and organizations that were facilitated by the ACC Foundation.

"Workforce is the driving force for every company and every industry. It is the number one ingredient for success for any enterprise and having a facility like this is absolutely key," said guest speaker Christopher Chung, CEO of The Economic Development Partnership of North Carolina. "We can grow talent through our investments in k-12 and higher education to produce that pipeline of qualified workers...We can groom talent through

customized training and working with employers to upskill the current workforce. With this new Biotechnology Center of Excellence, ACC is going to play a key role in growing and grooming that talent."

Alamance Community College is positioned – geographically and strategically – in the middle of North Carolina's most active biotechnology corridor. Indeed, Burlington is the nation's #1 small Metropolitan Statistical Area for research, testing and medical labs.

Student Services Center Opens

The new Student Services Center is a 12,200 square foot, \$6.7 million building that consolidates Admissions, Registrar's Office, Financial Aid, Cashier's Office, and the Office of the Vice President for Student Success inside a single, two-level location.

The Student Services Center now serves as the new entrance to the ACC campus core facing Jimmie Kerr Road and provides students with a "one-stop shop" to register and pay for classes, apply for financial aid, and talk to advisors. The top floor also includes a bank of computers for students to use with the help of an advising staff.

Public Safety Training Center

The plans for the Public Safety Training Center received a boost with a \$5.5 million appropriation from the NC General Assembly 2023-2024 state budget. The \$5.5 million will specifically fund the indoor shooting range that lacked full funding.

College Commits to Mental Health Awareness

“Mental health, growth, and planning are valuable when trying to pursue your dream. You have to be focused and remain in good mental health to stay organized and resilient. These are vital keys to life, adulthood, careers, and parenthood.” – Anonymous ACC Student

Alamance Community College instituted a new Quality Enhancement Plan (QEP) last year to identify strategies that will improve curriculum student success through enhanced mental health awareness, support, and services.

The five-year QEP initiative is required for ACC’s reaccreditation through the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC), the organization that accredits and reaccredits degree-granting higher education institutions in the Southern states. »

The College last year appointed a QEP Plan Creation Committee comprised of 16 members drawn from ACC's administration, faculty, staff, and student body. The committee reported to all college employees a list of six identified best practices for improving student mental health:

- **Employ an organizing framework to create a coherent college-wide approach.**
- **Integrate mental health support and services throughout the college.**
- **Involve faculty and staff, who are positioned to have a direct and immediate effect on students' mental health.**
- **Prioritize and promote student mental health at the executive level, from the President, to the Board, to college leadership.**
- **Provide different student populations with different kinds of support as needed.**
- **Amplify student voices: Engage students to provide feedback and guidance.**

Consequently, the College established a Student Support Center, located centrally in the main building. The Student Support Center is open to any student who may need mental health support, crisis support or short-term counseling or coaching. Since late summer 2023, the Center is operated under the auspices of the following:

Jennifer Brownell, Director of Wellness and Student Support

Coming from a background in advising and Career and College Promise (CCP), Brownell provides crisis support, short-term counseling/coaching and referral for longer term counseling. She also implements initiatives outlined in the College's QEP, focused on mental health and providing support to Student Life and Engagement, Disability Services, Single Stop and TRIO.

Baron Torres, Outreach Recruiter/First Year Mentor

Moving to this position from the Workforce Development division, the Spanish-fluent Torres is focused on recruiting underrepresented populations and continuing to work with those students as a mentor their first year at ACC. This position is also responsible for implementing a First Year Experience (FYE) pilot designed by the Strategic Planning group Team Learn.

Darsell Hadley, Administrative Assistant

With experience in Financial Aid, Placement Testing and Public Safety, Hadley provides oversight to the ACC Food Pantry, schedules student appointments for short-term counseling/coaching, disability services and Single Stop, assists in programming efforts and provides general support to students and visitors of the Student Support Center.

ACC Introduces New Logo

Alamance Community College's logo underwent its first reinvention in nearly 20 years and was unveiled publicly in early fall 2023. The College's Public Information & Marketing Office redesigned the existing logo to reflect the current spirit and values of ACC. During the College's Haw Fest celebration, students, faculty and staff had the opportunity to receive ACC stickers and limited-edition T-shirts emblazoned with the new logo. In the coming year, the new logo will transition into all marketing, letterhead, and business cards.



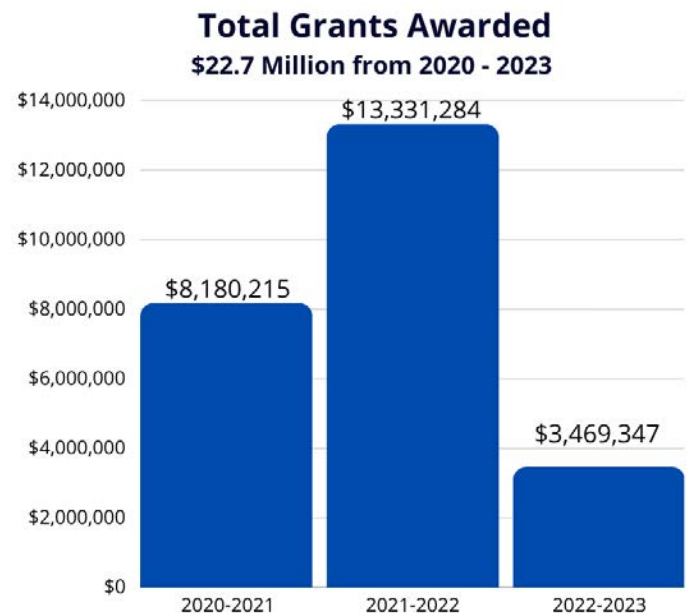
GRANTS

COLLEGE AWARDED \$24.79 MILLION IN GRANTS BETWEEN 2020-2023

Alamance Community College received \$24.9 million in state, federal and other grants over a three-year span from 2020 to 2023. The gifts are a valuable resource to ensure the College continues to offer key student-related programs, initiatives and equipment that are important in the future success of ACC's efforts to implement education and job-training for all students in Alamance County.

GOLDEN LEAF GRANT UNDERWRITES NEW PRACTICAL NURSING PROGRAM

The College received a \$200,000 Golden Leaf grant to help launch a new one-year Practical Nursing program in early 2024, designed to meet the growing demand for skilled healthcare professionals. The grant will pay for first-year personnel and supply costs for a cohort of 40 students.

ACC's Practical Nursing Program is designed to be completed in just one year, enabling students to fast-track their careers and enter the workforce sooner.

The program offers a comprehensive curriculum covering essential nursing skills, patient care, pharmacology, and more, ensuring that graduates are well prepared for their careers. Practical experience is integral to the program, allowing students to develop their clinical skills in real healthcare settings under the guidance of experienced instructors.

Graduates of the program will be eligible to sit for the NCLEX-PN® exam, the first step towards becoming licensed practical nurses (LPNs) and embarking on a rewarding healthcare journey.

"We are excited to offer this program as a vital contribution to the healthcare community," said Darlene Listopad, Department Head of Nursing at ACC. "Our goal is to empower students with the skills and knowledge they need to succeed in healthcare careers that are both fulfilling and in high demand."



ACC AWARDED \$2.5 MILLION GRANT TO EXPAND BIOMANUFACTURING CAPABILITIES

ACC was awarded a \$2,507,601 grant to support its bioscience industry efforts. The College received a \$2,006,880 grant, to be distributed over a three-year period, from the U.S. Economic Development Administration (EDA) that was matched with more than a half million dollars in NC General Assembly funds. ACC was one of 10 North Carolina community colleges to receive the NC Community College System grant from a \$16 million allocation to support the bioscience industry sector as part of the Build Back Better Regional Challenge Grant from the U.S. Department of Commerce Economic Development Administration. ACC's share was the second highest amount after Wake Tech. "This grant will allow our college to expand our biomanufacturing workforce training capabilities," said Yonnie Butler, Executive Director of ACC's Biotechnology Center of Excellence. "We will do this by creating simulated manufacturing lines in close partnership with several of the world's largest biopharma companies."

Since 2020, 73 life sciences companies have announced plans to either locate or expand their operations in North Carolina, according to the N.C. Biotechnology Center. This has equated to nearly 11,200 new jobs and more than \$8.39 billion in investment.

The NCCCS will work with BioNetwork, the system's life science training initiative, to "enhance and update biotechnology and life sciences industry training facilities, recruit industry trainers, recruit students from excluded populations, and to update and enhance curriculum.

Among other things, the grant focuses on equitable outcomes, building capacity in training labs, and increasing trained faculty.

COLLEGE AWARDED GRANT TO EXPAND DENTAL ASSISTING PROGRAM TO UNC CAMPUS

The College received a \$93,908 grant to purchase equipment to support its new satellite training facility at the Adams School of Dentistry on the UNC-Chapel Hill campus.

ACC expanded its Dental Assisting program to the UNC campus to offer students living in Durham and Orange counties an opportunity to train and earn a diploma starting in January 2023. No dental assisting program exists in those counties.

ACC at UNC, as the cohort is known, is expected to increase the number of current Dental Assisting II graduates available to the region's three counties of Alamance, Durham and Orange by almost

60 percent. A graduate certified in Dental Assisting II can earn a competitive salary because they can perform all legal expanded functions prescribed by a NC licensed dentist. ACC expects to provide an additional 24 Dental assisting II graduates each year with the ACC at UNC program.

ACC received the grant funds through The NC Community College System's Expanding Community College Economic Impact Grant program for the 2022-2023 fiscal year. North Carolina community colleges were eligible to apply for grant funds to expand and target efforts in a specific program that is proven to have high economic impacts in a region.

ACC established the ACC at UNC cohort because its Dental Assisting II program is at full capacity and the UNC facilities were available and offered to the college.

ACC MACHINING PROGRAM AWARDED FEDERAL ACE GRANT FOR CNC TRAINING

The Department of Defense awarded the College's Computer-Integrated Machining (CIM) program a generous grant that funds three years of free training in precision machining for approximately 150 students. This makes ACC North Carolina's first community college to be designated an "America's Cutting Edge (ACE)" approved facility. The America's Cutting Edge (ACE) program introduces students to a potential career path in Computer Numerical Control (CNC) machining on state-of-the-art equipment. Working with education partner NC A&T State University as a hub, ACC has plans to make its new ACE program a model for the state.

"NC A&T asked us to be part of their extended team and we were the first community college in North Carolina to accept the invitation and be approved," said James Adkins, Department Head of CIM, MET and Computer Integrated Drafting (CAD).

ACC's Computer-Integrated Machining program kicked off the ACE grant by hosting NC A&T's first boot camp in the community college's CIM lab. The ACE national initiative is aimed at recruiting and training workers to fill voids as operators, designers, and engineers in the machining industry. The program is comprised of a two-part series. Part One covers an online introduction to CNC and 3D modeling. Part Two is a hands-on lab training "boot camp," that provides opportunities for students to learn in a high-intensity environment through hands-on, in-person training. All training sessions are coordinated with ACC's Workforce Development division.

America's Cutting Edge (ACE) is supported by the U.S. Department of Defense. The collaboration is aimed at revitalizing U.S. manufacturing with a focus on the machine tool industry. America's capacity to design, make and use advanced machine tools has been in steady decline since the 1980s due to the migration of advanced machining and manufacturing overseas, according to Gardner Intelligence's 2020 World Machine Tool Report.

"Our Computer-Integrated Machining program at ACC is so much more than the name implies," said Adkins. "It is a precision machining operation where students learn life skills that allow them to work anywhere in the world. This is especially true for female students who are in high demand in the industry."

DEPT. OF COMMERCE GRANT CREATES PARTNERSHIP TO ENCOURAGE TECH TRADE JOBS

The U.S. Department of Commerce awarded a \$200,000 grant to create Steps4Growth, an initiative to take action against the deficit of North Carolina employees in the Cutting Edge Technical Trade. The grant, administered by North Carolina A&T State University, brings together Alamance Community College and other community colleges, universities, and employers to promote and fill the imbalance of jobs in these advanced job markets.

The partner institutions and other participants are creating a public awareness to highlight the skills that are needed or need to be refined, and how university and community college programs can keep pace with an advancing marketplace. Alamance Community College has partnered with NC A&T and Advanced Energy to promote better technicians for these jobs.

CRIME COMMISSION GRANT AIMS TO REDUCE YOUTH VIOLENCE WITH ACC'S HELP

The College received an Impact Alamance grant for \$53,000, later supplemented by \$168,100 from the Governor's Crime Commission, to fund a pilot project to help at-risk youth through the **Alamance Juvenile Opportunity Bridge (AJOB)**.

The goal of AJOB is to offer up to 30 at-risk youth, and those on probation for misdemeanor offenses, an option of taking ACC career exploration classes that include cosmetology, mechanical engineering, nursing, HVAC, culinary arts, auto repair, and others instead of performing traditional community service.

ACC agreed to provide weekly career exploration classes, including soft skills training that includes financial literacy, time management, and job behavior training.

The project created a coalition comprised of Alamance Community College, the Alamance-Burlington Schools, the Alamance Sheriff's Office, local police agencies, the NC Department of Public Safety-Division of Juvenile Justice and Delinquency Prevention, and Roots and Wings, Inc.

"Everybody wins with AJOB. The student, their family, ABSS, the community college, and our community. Having people more educated means less crime. We're excited to be working with all of the partners to develop this program which we hope will be a model for the rest of the state," said Dr. Algie Gatewood, ACC President.

THIS YEAR AT ACC

100% OF ACC NURSING GRADUATES PASS STATE CERTIFICATION EXAM

For the third time in four years, 100 percent of the Associate Degree in Nursing graduates passed the National Council Licensure Examination (NCLEX-RN) to earn their certification as Registered Nurses in the summer of 2023.

The NC Board of Nursing monitors colleges' NCLEX-RN pass rates for first-time test-takers. ACC's three-year average of nursing graduates passing the exam on their first try was 96.7%. Repeat test-takers have been 100 percent, according to Darlene Listopad, Department Head of ACC's Associate Degree Nursing program.

NCLEX is used across the country to determine if graduates from RN programs have acquired and retained the necessary knowledge, judgment and critical thinking skills during their nursing training to begin practicing as an entry-level RN.

In spring 2020, all 24 graduates in the Associate Degree day program achieved a 100% passing mark, and again in 2021 all 20 graduates hit the 100% passing rate. COVID had an effect in 2022 when 39 of 42 graduates passed with a 92.86% mark before the program returned in 2023 to the 100% passing rate.

"Passing the NCLEX so quickly after completing the program has allowed our students to enter the workforce to provide excellent and much-needed health care during the pandemic," said Dr. Lisa Johnson, Vice President of Instruction.

BLET PROGRAM ACHIEVES RECORD ENROLLMENT, RANKS AS LARGEST IN THE STATE

The College solidified its position as a leading institution in law enforcement education as its Basic Law Enforcement Training (BLET) program achieved a record-breaking milestone. Out of 68 BLET sites in North Carolina, ACC had the largest class heading into the fall 2023 semester: 48 full-time students and 6 limited enrollees.

Since its inception, ACC's BLET program has garnered significant attention for its comprehensive curriculum, hands-on training, and partnerships with local law enforcement agencies. The program's reputation for producing highly skilled officers has played a key role in attracting a surge of enrollments.

"I attribute this news to our BLET staff and instructors," said Christopher Verdeck, Director of ACC's BLET program. "Our past cadets are our best recruiters. When they graduate they go to their respective agencies, talk about their experience at ACC, and that draws more new students to us. We also follow up continuously with the cadets once they register to help them through the process."

ACC's BLET program goes beyond standard instruction. Students undergo rigorous physical and mental training, simulated scenarios, and real-world experiences that prepare them for the dynamic challenges faced by law enforcement officers.

"While North Carolina mandates 640 hours for a BLET program, our academy at ACC is 757 hours," added Verdeck. "We add hours to the higher liability topics, and we add to the final class called Impartial Policing, which is about recognizing bias. We think that's important."

ACC's BLET program is not only fostering academic excellence but also bolstering public safety in the communities it serves. As its enrollment continues to soar, ACC remains steadfast in its dedication to shaping the next generation of law enforcement professionals and empowering them to protect and serve with integrity and distinction.

ACC, CAMPBELL PARTNER TO GIVE STUDENTS HEAD START IN HEALTH SCIENCES

ACC and Campbell University signed an agreement in late 2022 that opened the door for qualified ACC students to pursue careers as health professionals in the university's College of Pharmacy & Health Sciences (CPHS).

Due to chronic shortages of health professionals in rural areas, Campbell University worked with ACC to create a program through which qualified students are offered priority interviews to enter Campbell by following a distinct academic protocol and by demonstrating high achievement.

The agreement provides two pathways toward full admission to Campbell University for high-achieving ACC students: the

Guaranteed Interview Program permits qualified students to be interviewed for the College of Pharmacy & Health Sciences, following an acknowledged rigorous health science curriculum at ACC. The Passport Program allows qualified students who come from rural areas, low socioeconomic status, and are underrepresented minorities to be granted an interview for programs in the College of Pharmacy & Health Sciences after matriculating through a pre-health curriculum at ACC.

As part of the agreement, Campbell University will designate a faculty or staff member to serve as a liaison between Campbell and ACC to coordinate and direct the programs, facilitate the interviews, assist with development of a pre-pharmacy club and review recommendations for admission to the programs.

"We welcome the opportunity to foster continued opportunities for ACC students as they pursue their education aspirations and look forward to a strong relationship with the institution for years to come," said Dr. Michael L. Adams, Dean of the Campbell University College of Pharmacy & Health Sciences.

ACC, NC CENTRAL EXPAND EAGLE ACCESS PROGRAM

Pharmaceutical and biomedical sciences courses added to curriculum

ACC expanded a preexisting transfer agreement with NC Central University (NCCU) in an effort to enhance the talent pipeline for North Carolina's fast-growing life sciences industry.

The Eagle ACCess program now allows NCCU to offer ACC students courses required to complete a Bachelor of Science in Pharmaceutical Sciences and Bachelor of Science in Biomedical Sciences degree programs. All classes, academic support and advising are provided on ACC's campus or through distance learning options so that students will not have to travel beyond ACC to earn a bachelor's degree. ACC students also have access to NCCU's vast digital library resources and the opportunity to engage in departmental activities and student organizations.

The life sciences industry in North Carolina has grown by nearly 40% over the past 10 years. As one of the top states for industry employment, North Carolina's pharma manufacturing field is also twice the size of the national average, further underscoring the benefits of the Eagle ACCess program for corporate partners.

"By offering a bachelor's degree on the ACC campus, we provide a seamless pathway for our students to continue their education and obtain advanced credentials in a high-demand field," said ACC President Dr. Algie Gatewood. This is the second such agreement signed between the institutions. In 2017, the Eagle Access program established eight associate- and bachelor-degree programs that are delivered jointly through ACC and NCCU, including several hybrid courses provided on-campus or online.

ACC AWARDS DEGREES, CREDENTIALS TO 978 GRADUATES

The College completed its 2022-2023 academic year with a total of 978 curriculum and high school equivalency graduates during the annual commencement ceremony held at Elon University in June 2023.

Keynote speaker was Reagan Chandler Gural, President of the Alamance Chamber of Commerce. A graduate of ACC's Business Administration program, Gural worked in banking for eight years until she joined the Alamance Chamber, where she has served as president since 2021. The Triad Business Journal named her as a "40 Under 40 Leader" and anointed her as a 2023 Outstanding Woman in Business. Gural received ACC's Distinguished Alumni of the Year Award in 2021.

ACC President Dr. Algie Gatewood presided over the final commencement of his long academic career. He announced last May that he would retire on July 1 after nearly ten years as the college's leader.

ACC MOCK TRIAL TEAM EXCELS AT REGIONAL TOURNAMENT

The ACC Mock Trial Team had a stellar 2022-2023 by first beating UNC-Charlotte at an invitational held at Davidson College, then tying for a respectable fifth place at the 2023 Regional Championship last winter on the UNC Chapel Hill campus.

The Regional pitted ACC's student team against 17 other competing schools that included Duke University, UNC Chapel Hill, Davidson College, UNC-Wilmington, and Western Carolina.

Student Jade Coulbourn earned one of 10 coveted outstanding witness awards presented at the event, ACC's first individual award since the team was founded in 2014.

ACC is one of the few community colleges in the nation to take on the challenge of mock trial competition. The American Mock Trial Association provides college students opportunities to develop critical thinking and public speaking skills, as well as a knowledge of legal practices and procedures.

"I think the many co-curricular learning programs sponsored by ACC is some of the most important work we do because it bridges the gap between the classroom and the world outside." This creates engaging learning experiences that transform students' lives," said English instructor Dr. Kevin Sargent, Director of ACC's Mock Trial Team.

Under the tutelage of Dr. Sargent, ACC has sported a mock trial team for the past seven years, competing at a high level against universities and four-year colleges at regional tournaments. Mary Spektor, an ACC mock trial team member in 2020, is currently a student in the Elon University School of Law.

The annual "Girls Take Over Tech," an open house specifically for prospective female students, returned for its sixth year on the ACC campus in December 2022.

The 2022 event brought almost 100 young women to the College's Advanced Applied Technology Center to explore industrial career opportunities as demonstrated by females working in the industry, and currently enrolled female students in Mechatronics Engineering Technology, Welding Technology, Computer-Integrated Machining, Automotive Systems, and Air Conditioning, Heating & Refrigeration. WISDEM (Women in Industrial Science, Design, Engineering and Manufacturing) organized the event.

The young women had numerous opportunities to get some hands-on experience in the various industrial programs.

Faculty and students from other programs staffed information tables for the event, including Animal Care and Management, Biotechnology, Horticulture/Agricultural Biotechnology, Emergency Medical Services, Advertising and Graphic Design, and many others.

HORTICULTURE FINISHES 11TH OUT OF 47 AT NATIONAL LANDSCAPING COMPETITION

Horticulture Technology students excelled at the 47th National Collegiate Landscape Competition as ACC's student team finished 11th out of 47 colleges and universities from across the U.S.

Held on the campus of Mississippi State University last March, ACC's 14-member team matched their horticulture and landscaping skills in 29 contests against 529 competing students. Individual students and teams placed high in the competitions to accumulate scores that pushed ACC into the upper echelons of the competition.

Among ACC's 47 competitors were Brigham Young University, Michigan State University, and Virginia Tech. By finishing in 11th place, ACC scored ahead of University of Georgia, Kansas State University, Auburn University and approximately 9 community colleges.

ACC's Cody Byrd finished as the second place overall student among all competitors. His second place in the Small Engine Repair category and other events helped his scoring for the entire competition.

This was the 20th consecutive year that ACC's Horticulture department had attended this national event, including virtual events due to COVID-19 in 2020 and 2021. The annual event provides students opportunities to spend a day in workshops led by industry professionals, attend a career fair featuring many top landscape companies from across the U.S., and pit their horticulture skills in numerous competitions.

COLLEGE'S 'MANUFACTURING DAY' IS HANDS-ON EVENT FOR HIGH SCHOOL STUDENTS

Manufacturing Day at ACC was held in October 2022 in the Advanced Applied Technology Center (AATC). The goal of this annual event is to inspire the next generation to consider careers in modern manufacturing. The College highlighted its Computer-Integrated Machining, Automotive Systems Technology, Industrial Systems Technology, and Welding Technology programs. Alamance-Burlington Schools System (ABSS) students who attended this hands-on event had expressed an interest in manufacturing and trade careers. Students rotated through the topic areas, observed demonstrations, and participated in hands-on activities.



ACC PRESIDENT, TRUSTEES PUSH COMMUNITY COLLEGE AGENDA WITH LEGISLATORS

Six members of the ACC Board of Trustees accompanied President Dr. Algie Gatewood to meet with elected officials in spring 2023 during the annual North Carolina Community College Legislative Day.

The centerpiece of Legislative Day was the opportunity for local community college leaders to meet with state representatives to urge approval of the NC Community College System (NCCCS) budget request.

"This year looks very promising for community colleges, perhaps one of the most promising budget years in recent history," said President Gatewood. "Community colleges are essential in meeting the workforce and training needs of today's economy."

The plan last spring called for the General Assembly to increase state funding by \$232 million over the next two years to strengthen and stabilize all campuses. In early fall 2023 the legislature returned with its budget that allocated more than was requested, including an unprecedented amount of allocations to individual colleges for workforce and health care programs.

ACC OPEN HOUSE, JOB FAIR DRAW LARGE CROWD

ACC welcomed more than 500 prospective students, families, and community members during the Community Job Fair, 2023 Open House, and the Biotechnology Center of Excellence Open House events in spring 2023. More than 60 area businesses participated in the Community Job Fair. Representatives from local government, law enforcement agencies, childcare facilities, transportation, and more were present to speak with ACC students and community attendees about potential careers in their field of interest. Faculty and staff shared information on academic programs, enrollment, and support resources with over 200 families at the 2023 Open House. Those interested were given guided tours of the campus and attended information sessions on financial aid and Career and College Promise. College representatives were available to help future students apply and enroll in courses.

The Biotechnology Center of Excellence opened its doors to local high school students to tour classrooms and state-of-the-art labs where students receive hands-on training in Biotechnology, Histotechnology, and Agricultural-Biotechnology programs. Other ACC health-related programs -- Nursing, Dental Assisting, Emergency Medical Sciences, Medical Assisting Technology, and Medical Laboratory Technology -- were on-site to provide information to students about additional educational opportunities offered on ACC's campus.



Chef Travis Gunter

CULINARY CHEF MAKING MOST OF CAREER – EVEN SERVING THE PRESIDENT OF FRANCE

Chef Travis Gunter has carved out an impressive career path since earning his Culinary Arts degree in 2006. His journey led him southward to New Orleans, he has opened starred restaurants, and fed work crews on oil rigs in the Gulf of Mexico. By far his most impressive achievement was perhaps the rare opportunity in December 2022 to prepare a Southern luncheon for Emmanuel Macron, the President of France.

Traveling to New Orleans on the heels of a state dinner with President Biden at the White House, President Macron and the French First Lady Brigitte Macron were treated to specialty Cajun-style dishes that only a true Southerner like Chef Gunter would know first-hand, thanks to his training at Alamance Community College.

A native of Pittsboro, NC, Travis Gunter first learned about culinary arts while in the U.S. Marine Corp. Honorably discharged, Travis worked in the kitchen of the Carolina Hurricanes hockey team and later enrolled at Alamance Community College upon the recommendation of his employer. In ACC's Culinary program, Travis helped build a Hot Foods Junior Team that subsequently won second place

in state competition for two consecutive years. Upon graduation, Travis worked as an Executive Sous-chef in South Carolina, Raleigh NC, and in Tennessee.

He gained national exposure on the CNBC show, Restaurant Start Up, which led to an offer he could not refuse - moving to a much bigger national corporation. Travis became the Sous-chef at Bravo/Brio Restaurant Group (BBRG) just outside New Orleans. This group of 116 restaurants included five sites in North Carolina. Along the way, he has volunteered to provide food for special events, to teach mini-classes, and to assist with fund-raising occasions.

Acknowledging that his time at ACC opened his eyes to an array of exciting culinary possibilities, Travis in recent years opted to work aboard two different oil rigs in the Gulf of Mexico to feed the hardworking crews. For 28-36 days at a time, he first served as kitchen manager on the Thunderhorse, the largest rig in the Gulf, followed by a promotion to camp boss over another rig where he managed 17 kitchen workers.

Travis is currently employed as a manager within The Ralph Brennan Restaurant Group in New Orleans' French Quarter. It was in this capacity that Travis learned the week before Thanksgiving 2022 that French President Macron and his wife would be their guests in early December for a meal at the Louisiana State Museums in historic Jackson Square. Secret Service canines walked through to check for explosives before the guests of honor arrived. The governor of Louisiana and Ralph Brennan, the owner of the five-restaurant group where Travis is employed, were also in attendance. Chef Gunter and his staff custom-packaged a New Orleans-style sampler menu to serve to President Macron and his wife.

"I was too busy in the back to see President Macron but I did get a little wave from Mrs. Macron when she came through," said Travis. "But they did love everything we served them."

When Travis Gunter was presented with Alamance Community College's Distinguished Alumni Award in 2017, his career was impressive at that time. With more experiences on his resume since then, it seems the sky's the limit to what he will achieve.

Carolyn Rhode, Executive Director of the ACC Foundation and Vice President of Institutional Advancement, was the recipient of the 2022 Distinguished Service Award by NC CORD, the statewide organization for NC Community College Resource Development officers.

ALAMANCE-BURLINGTON SCHOOLS NAMED 2022 ORGANIZATION OF THE YEAR

Alamance-Burlington Schools System (ABSS) was designated as the College's 2022 Organization of the Year in recognition of the outstanding support the system has consistently provided to ACC students and graduates. The ACC Foundation facilitates the nomination process for this annual award.

"Hundreds of our high school students are currently taking advantage of many ACC programs including the Pre-Collegiate Academy, Early College, and Career Technical Pathways," said Dr. Dain Butler, ABSS Superintendent. "These opportunities position students for success far beyond high school. I applaud ACC for having the mindset to serve students where they are in their lives, removing the often familiar obstacles that may impede a student's educational goals, and providing them the support services to help them excel beyond just academics."

Among the partnership highlights exhibited by ABSS are:

- 22 ABSS employees serve on various ACC department advisory boards.
- ABSS hosts ACC classes on five of their high school campuses.
- ABSS generously provides textbooks/access codes to Career and College Promise students that take ACC classes on one of their campuses. Enrollment has risen from 300 students to more than 1,200 over the last few years.
- ABSS works with the College to place students enrolled in the Teacher Preparation program in their classrooms for field experience. Students are placed in a classroom and work with a cooperating teacher each week for a semester-long experience.
- ABSS Early College makes its home on ACC's main campus, allowing this state-accredited high school and its approximately 250 students to take classes in university transfer, Career Technical and STEM programs.
- The Alamance Scholars program aims to increase the diversity of prospective teachers in ABSS to better reflect the county's student population. The 2021 agreement between ACC, ABSS and Elon University established a pathway from high school to community college to a bachelor's degree in education for students with financial need who desire a career in education in Alamance County.
- Apprenticeships through the Career Accelerator Program (CAP) have brought together in partnership ACC, ABSS, the Alamance Chamber, and 12 local advanced manufacturing firms that provide high school students opportunities over three years to learn a skilled trade while earning a paycheck and full-time placement in a career.

Janet Byrd, Nurse Aide Instructor

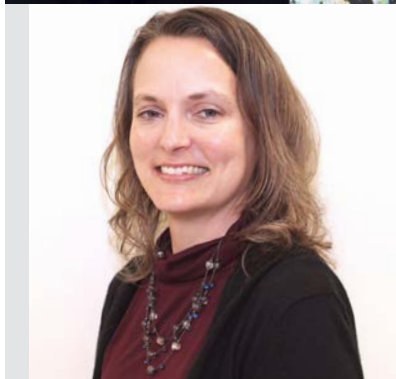

In the two years that he was a student at ACC, Shane laid out plans for his future education and career goals by taking courses that included psychology, sociology, and graphic design classes. Determined to make his way to a successful life, Lay enrolled in ACC's combined English for HVAC and HVAC/Refrigeration training, where students improve English language skills while simultaneously earning HVAC skills for a credential. ECI's RegO facilities have employed numerous ACC graduates, as well as student apprentices.

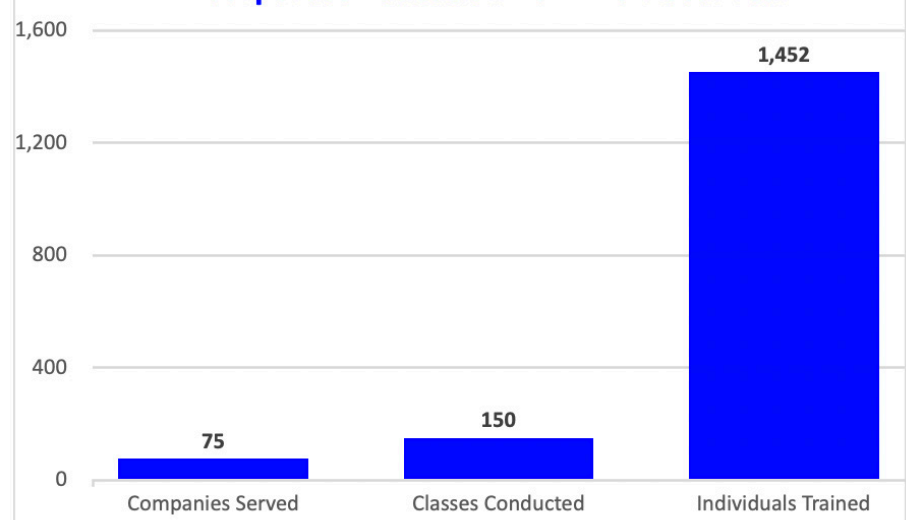


Employers Luncheon Provides Networking Opportunity

DISTANCE LEARNING

ENROLLMENT

During the 2022-2023 academic year, ACC's online course enrollment accounted for 44% of total curriculum FTE. When combined with hybrid, blended, and hyflex courses, this percentage increases to 58%. During the 2022-2023 academic year, most courses continued to have some online presence. In the 2022-2023 year, ACC offered 1200 fully online sections (E section courses); 19 hyflex courses, 346 hybrid courses, and 296 blended courses. While the number of fully online sections decreased some from the previous year, fully online courses were still up from the average of 25% of courses offered being fully online prior to the COVID-19 pandemic.

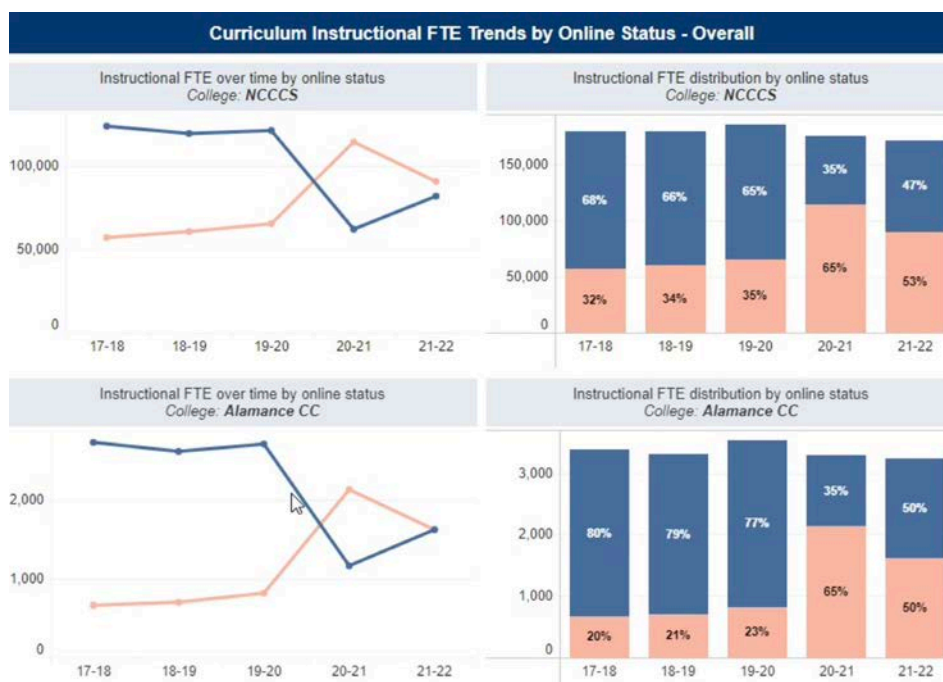
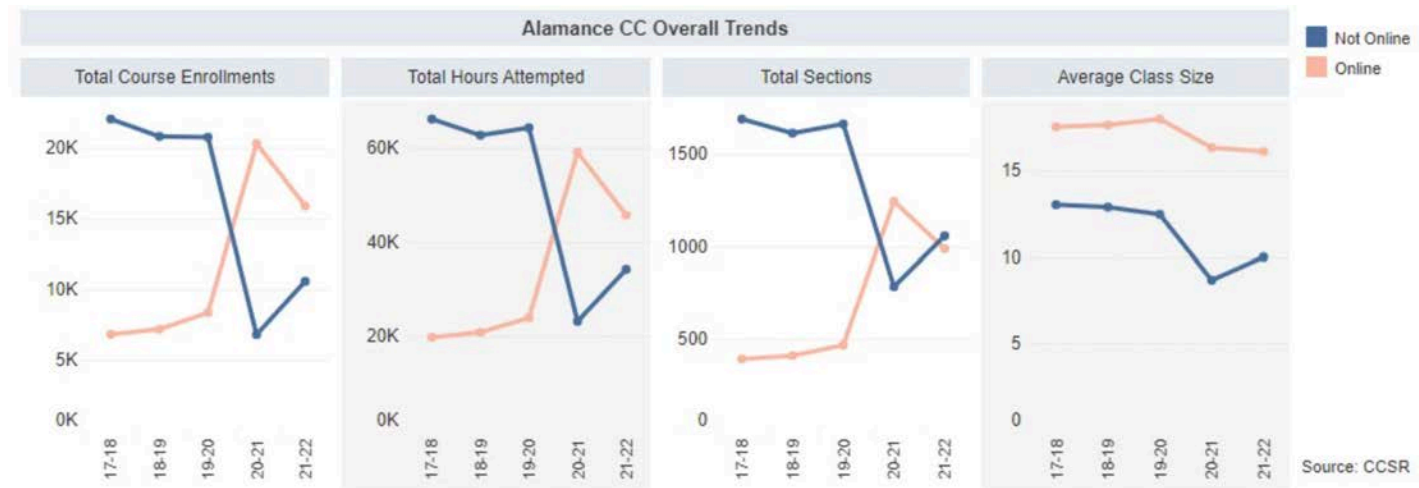

ACC AWARDED \$20,000 UW GRANT FOR HS EQUIVALENCY PROGRAM

ACC's College and Career Readiness (CCR) division was awarded a \$20,000 United Way Community Grant, one of the largest allotments in 2022. This was the seventh consecutive year the department received a United Way gift.

CCR used the grant to cover High School Equivalency (HSE) needs, such as official testing fees, graduation fees, staff training expenses, resource fair expenses, and distress funds.

"This will help many people in Alamance County so they do not have to worry about paying for their HSE tests to graduate, including our incarcerated graduates who are participating in classes to earn their high school credentials," said Jennifer Mock, Director of College and Career Readiness.

The flexible grant also covered student expenses such as gasoline, food, and books. It also supplemented a literacy specialist who spends time in the community to engage potential students and assist current ones.

at the City Gate Dream Center and Burlington Housing Authority provided an opportunity for ACC volunteers to hand out over 1,500 school supply items, funded by United Way, and information on ACC programs. Some helped cook, set up, give out school supplies, gave out socks, cut watermelon, engaged in conversation, and did whatever needed to be done for the community.

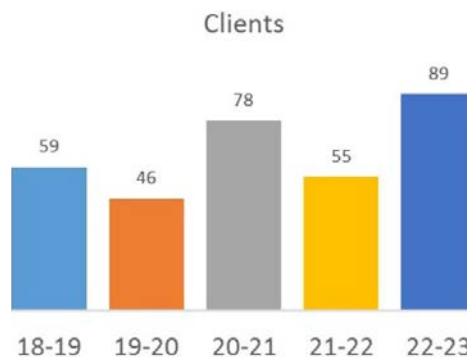

The goal of this committee is to stimulate entrepreneurship and to encourage high-growth small business enterprises to launch, scale and grow in Alamance County.
- SBC hosted the Women and Minority Business Summit in June 2023, offering 12 classes and 15 speakers. It featured the first Premier Pursuits Small Business Showcase, sponsored by a \$5,000 NCIDEA ENGAGE Grant awarded to the SBC for its efforts to provide networking, education and growth opportunities for diverse populations, including Historically Underutilized Businesses and Women and Minority Enterprises.
- Lewis was interviewed on WXLV-TV's Triad Today and talked about the Small Business Center.

SBC HOLDS FIRST TRUCKING SUMMIT

The Small Business Center (SBC) in February 2023 held the first Small Business Trucking Summit for individuals looking to start businesses or offer services in the fields of Transportation and Logistics. SBC offered five sessions focused on the fundamentals of entering the trucking industry, notable regulations and licensing requirements for starting a business, and other considerations for planning and operating a successful, growth-oriented venture. Featured speakers included local leaders from Cross Country Trucking, DualVision Accounting Firm, Charisma Capital and Charisma Insurance, as well as the Director of Procurement for UberFreight, currently a Top Ten \$17 billion North American Logistics Company.

It works cooperatively with the Chamber of Commerce, local municipalities, corporations, and industry experts.

FINANCIALS 2022-23

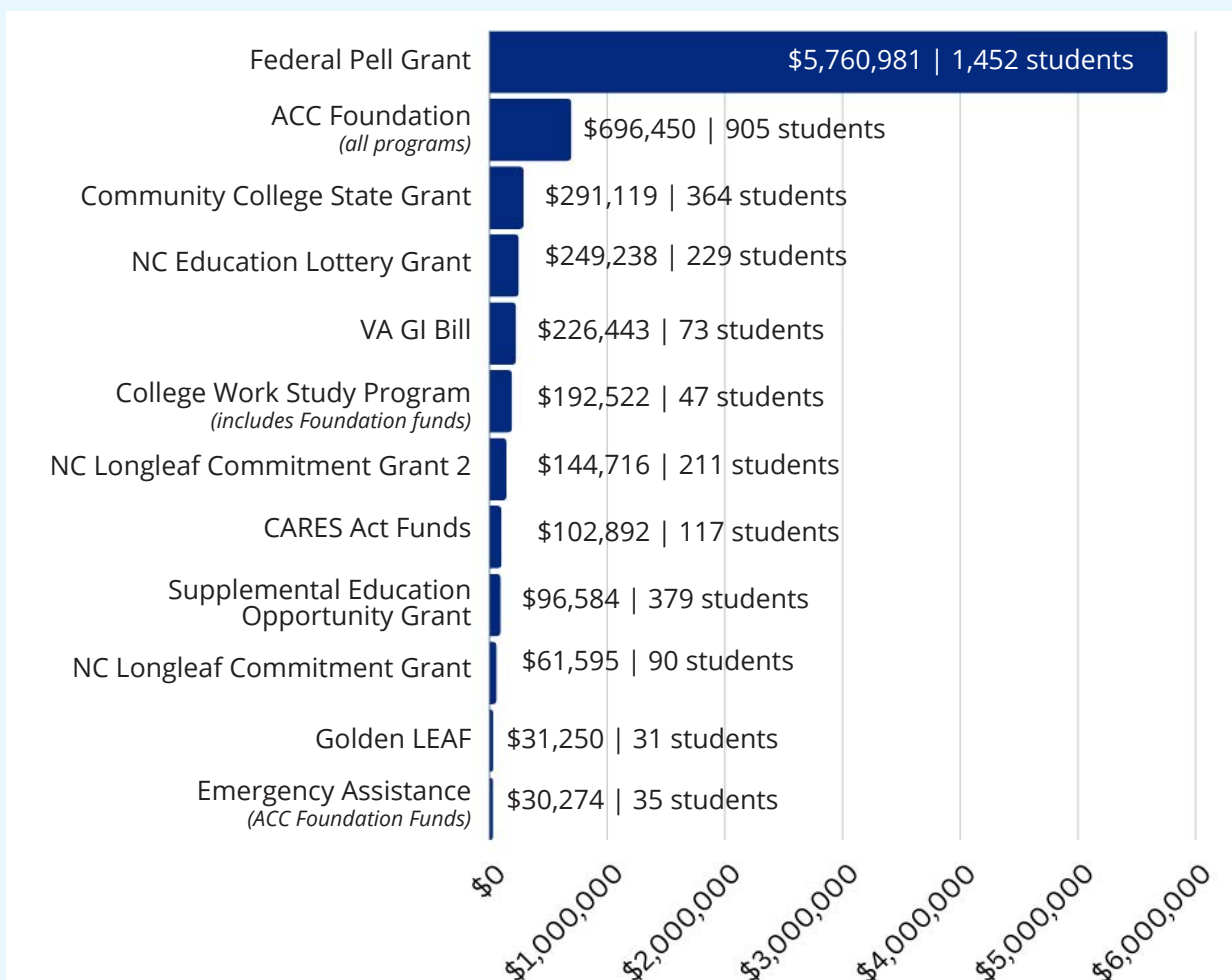
"IN 2022-2023, THE FINANCIAL AID OFFICE PROCESSED MORE THAN \$7 MILLION IN STUDENT AID. We saw several changes in financial assistance programs. The COVID-19 Higher Education Emergency Relief (HERF) funding dissolved; we now show a larger gap where our office has processed the last of our allocation going from \$3 million to a little over \$100,000. Our state grant funding increased because eligibility changed and we processed more aid to North Carolinians through the Community College Grant and the Education Lottery program. In addition, the NC Longleaf Commitment grant for recent high school graduates expanded because many of those students returned to ACC giving us an additional increase in funding from the state for Part I and Part II of those programs. The Federal Pell grant program increased as a result of the economy's inflation. Our Foundation office has been an incredible support with scholarships while our federal and state programs consistently change."

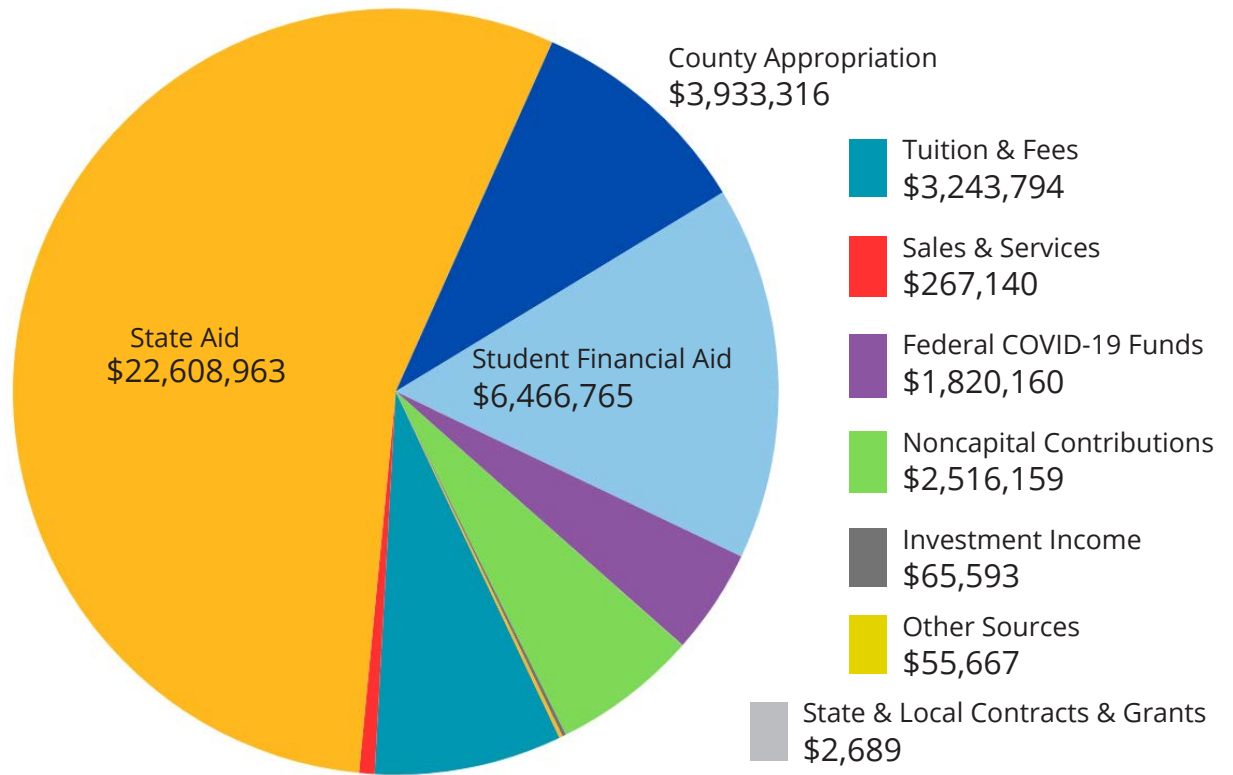

FINANCIALS 2022-23

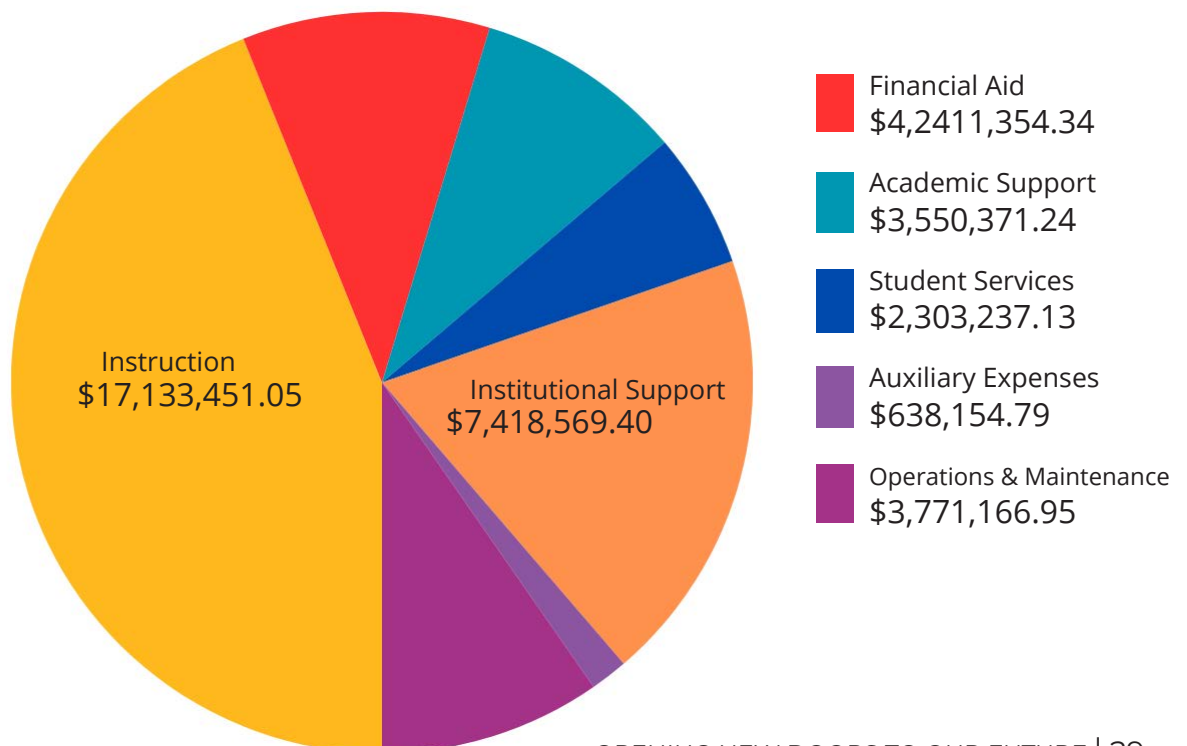
Current Fund Revenues: \$38,892,218*

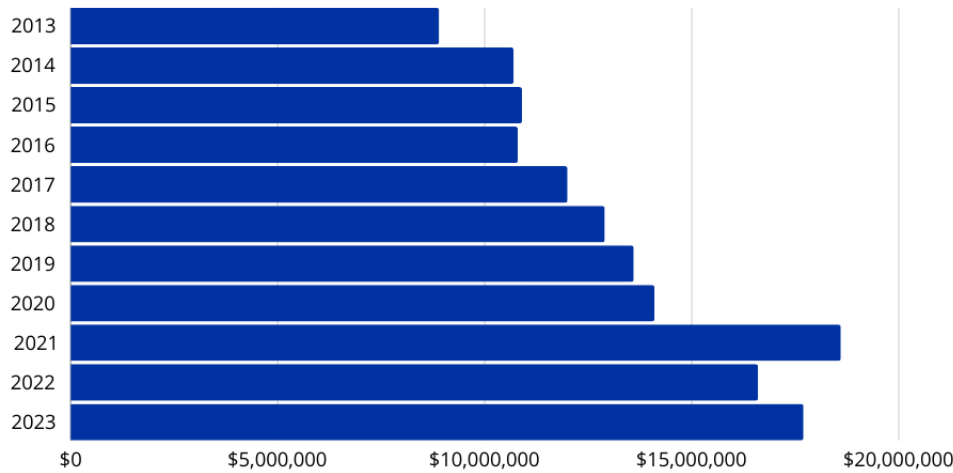

VALUE OF FINANCIAL ASSETS*

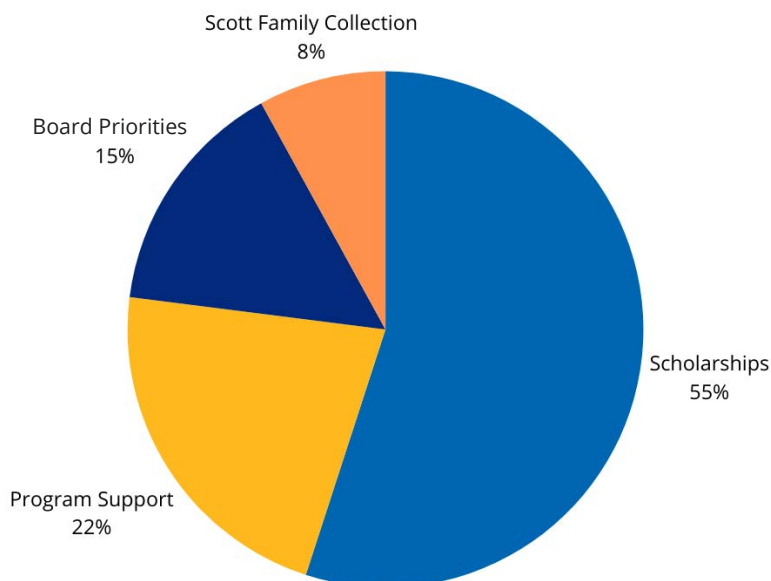

**Accrual basis*

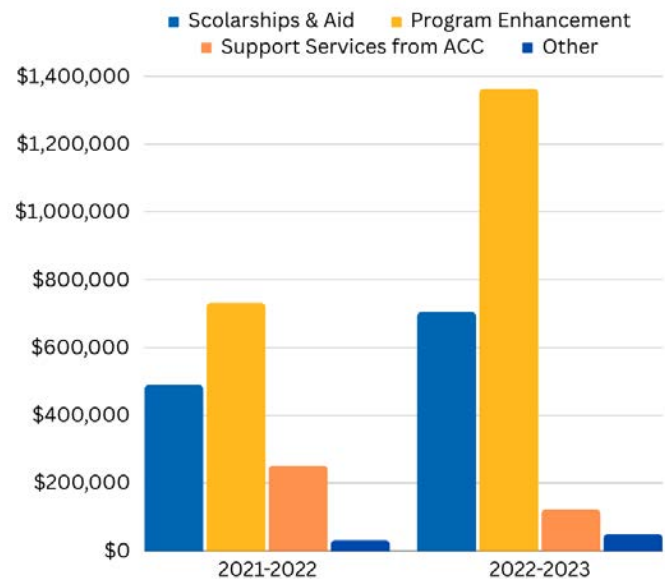
MANAGEMENT

The ACC Foundation's financial assets are overseen by an Investment Committee consisting of ten volunteer business professionals. The Investment Committee establishes policies for the management of the assets and employs Trust Company of the South to carry out day-to-day investment activities.

PROGRAMS AND EXPENSES



SPENDING

The ACC Foundation employs spending and investment policies designed to provide a stable flow of support for the needs of ACC students and ACC educational programs, while preserving the future purchasing power of the endowment. The spending rate for the endowment assets is currently up to 5% of the average value of each fund over the previous 12 quarters, unless otherwise specified in the donor agreement.

DRAMATIC INCREASE IN SCHOLARSHIPS AWARDED

The demand for scholarships more than doubled at 74% in 2022-2023.

Among the factors were:

- Enrollment rebounding after the pandemic
- Significant increase in the cost of books and supplies for students
Previously the average textbook award to students was \$500; currently it is \$1,000 or more despite unchanged tuition rates
- COVID-19 benefit programs ending for students
- ACC Foundation applications prominently located on the ACC website

FOUNDATION FUNDS COSMETOLOGY EQUIPMENT NEEDS

With the assistance of an anonymous family foundation, the ACC Foundation responded to a \$47,290 funding request from the College's Cosmetology program for equipment needed to comply with state standards.

The State of North Carolina requires schools of cosmetology to comply with strict requirements and receive a grade similar to restaurants. The State carefully monitors the ratio of equipment to students and sanitation practices.

The Foundation consequently funded:

- 20 two-sided sturdy styling stations with mirrors, shelves, outlets and tool holders. Cosmetology's previous stations were worn down to the particleboards.
- 13 standing Sol-Air driers replacing hood driers on which height adjustment levers were broken. The broken equipment prevented students from fitting hood driers to clients' heads properly.
- A reception desk with customer counter and locking cash drawer. The previous desk had been in use for 25 years.
- "We thank the Foundation," said Heather Lawson, Cosmetology Department Head. "The new equipment now provides an up-to-date appearance for our instructional salon, which improves the experience of students, instructors and clients."

The ACC Foundation's annual **Scholar-Donor Reception** returned to campus in October 2022 after suspending the in-person event during the pandemic. Student scholarship recipients had an opportunity to meet face-to-face with some of their benefactors. More than 200 people gathered on the college campus to converse, enjoy refreshments provided by Culinary Arts students, and listen to guest speakers.

CityGate Dream Center in east Burlington has hosted classes sponsored by CCR since fall 2018. By providing \$10,000 for childcare over a full-academic year, the ACC Foundation is helping many more individuals to take the classes they need to build better lives for themselves and their families.

The Foundation announced the creation of three new named scholarships this year that will benefit the needs of qualified students.

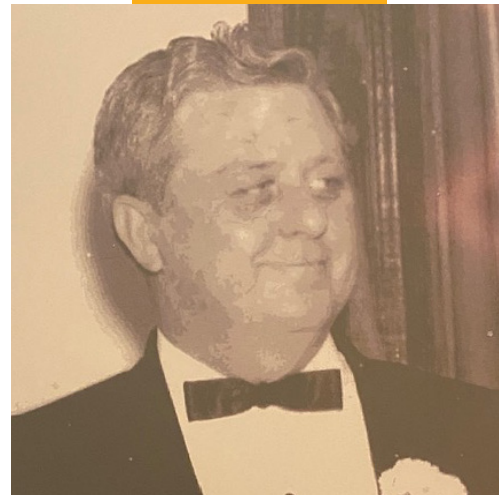
THE SARAH ELIZABETH SYKES JONES MEMORIAL SCHOLARSHIP

In recognition of a long-time devotion to caring and nurturing others more so than herself, her children established this memorial scholarship with deep, abiding remembrance and respect for her. Her compassion and service to others never wavered throughout her lifetime. Always willing to help others, honest to the core, soft spoken, and gentle in spirit, Mrs. Jones made her mark on her children and those who knew her. Her legacy of helping others continues with this scholarship.



THE WINFRED LEE JONES, SR. SCHOLARSHIP

Winfred Lee Jones, Sr. was born in the village of Hopedale (near Haw River) and briefly attended schools in the Burlington area. For the remainder of his life, he resided in Haw River. His children established this memorial scholarship in honor and remembrance of his dedication to the support and well-being of his family. His hardships in childhood shaped his core values of fairness and justice. His work as an activist and advocate for the "fundamental principles" of workers' rights and the doctrine of fairness in the workplace immeasurably define his legacy. Both scholarships are intended to provide financial assistance and support to in-need first-year students in these ACC's two-year degree programs: Biotechnology, Histotechnology, Medical Lab Technology or Information Technology. Combined, the two new Jones scholarships will help 2-3 students per year attend Alamance Community College.



THANT SIN AND JOHN W. WEATHERS MEMORIAL SCHOLARSHIP

Born in Thailand, Thant and his family immigrated to the United States when Thant was two years old. Thant grew up in Chapel Hill and graduated from Chapel Hill High School in 2013, where he was active in the marching band. After making a remarkable academic turnaround, Thant had dreams of attending college. He began his studies at ACC and planned to transfer to UNC-Chapel Hill. John Weathers and Janie Benson befriended Thant and his family and considered him one of their own. John, a native of Forest City in Rutherford County NC, earned a Master's Degree in Business Administration, and held a Juris Doctor degree. He enjoyed a successful career in banking, economic development and business consulting. For over 20 years, John owned and operated Hubcap Annie in Raleigh, a small business selling hubcaps and wheels. 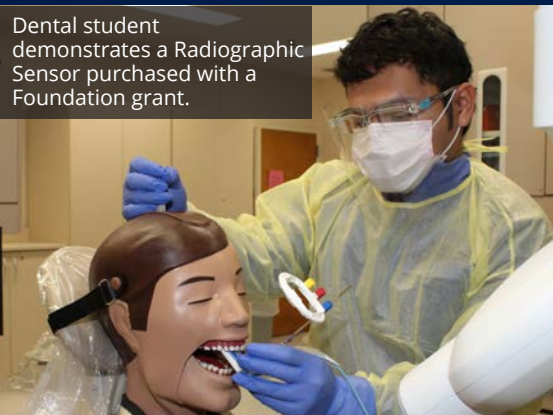

FOUNDATION AWARDS \$81,000 TO 11 FACULTY-STAFF GRANTS IN 2022-2023

The Foundation funded 11 faculty/staff grants in the total amount of \$81,067 during fiscal year 2022-2023. Hundreds of individuals at Alamance Community College, Alamance-Burlington Schools and in the community have been impacted by these innovative projects initiated by ACC faculty and staff.

AGD Makerspace Funding, \$10,000

To provide funding for two students to staff the Advertising & Graphic Design interdisciplinary exploration and learning Makerspace for three hours per day, M-F over a 30-week period.

CDL Promotion, \$10,000

To promote the Center for Development and Leadership (CDL), conduct professional development activities, and purchase resource material to support ACC faculty and staff.

Childcare for ACR classes at Dream Center, \$10,000

To help fund childcare services at City Gate Dream Center for ACC English language learners and high school equivalency students.

Creating Student Opportunity Through Service Learning, \$9,941

To fund a cohort of nine faculty members who will integrate service learning into their University Transfer courses and conduct a celebratory event for students to showcase their service learning projects.

Digital Marketing Campaign, \$10,000

To increase digital marketing footprint and brand awareness for ACC as a whole.

Life Science Club Executive Speaker Series, \$3,000

To fund monthly lunchtime sessions to help life science students better understand how to influence their job application process.

Professional Learning Community within the CCR Program – Year 4, \$3,600

To continue the program that introduces College and Career Readiness students to additional resources and careers.

Recruitment Enhancement, \$5,000

To purchase additional items to distribute at college fairs and community events to promote ACC.

Resources for Teacher Preparation Program, \$5,000

To introduce the Collaborative Learning Lab to ABSS students and teachers, ACC students, Alamance Scholars, and Elon faculty to benefit the Alamance County Teacher Preparation Program.

WAYS TO GIVE TO ACCF

Charitable Giving Overview

Charitable giving provides personal satisfaction to the donor along with estate and income tax deductions to reduce taxes.

From a financial planning perspective, lifetime charitable gifts are generally made to achieve income tax deductions and slow the growth of an estate. At death, if an estate plan is so arranged that the heirs will receive a satisfactory net inheritance then estate assets can also be left to charities via bequest. Charitable bequests are eligible for an estate tax deduction and must be made by the estate owner in the estate planning documents.

Advantages of charitable giving include:

- Immediate reduction in estate size.
- Income Tax Deduction if made during lifetime.
- Sense of satisfaction for good works.
- Special charitable trusts exist that offer the above benefits and still provide the donor with income from the gifted asset.

Many people prefer using charitable gifts to reduce their estate tax liability because they believe their dollars are better spent and allocated by a charity or foundation than a wasteful or inefficient government department. Additionally, and especially with a foundation (like ACCF), the donor can better control which people/causes the money will help.

Below are several ways charitable gifts may be made to ACCF.

Cash:

- Cash gifts are immediate and, if you itemize your taxes, your outright gifts of cash are fully deductible up to 60% of AGI for federal income tax purposes.

Appreciated securities:

- A gift of securities can be a good option for accumulated stocks, bonds or mutual funds that have appreciated in value and would be subject to a 15% or 20% (based on tax bracket) capital gains tax if sold.
- Gifting long-term appreciated stock, bonds or mutual funds may offer you two tax savings:

- You avoid paying capital gains tax on the increase of the value of the securities.
- You receive a tax deduction for the full fair market value of the securities at the time of donation.
- Funds may offer you two tax savings:
 1. You avoid paying capital gains tax on the increase of the value of the securities.
 2. You receive a tax deduction for the full fair market value of the securities at the time of donation.

IRAs or Retirement Plan Assets:

- Tax deferred retirement plans represent one of the most significant, yet underutilized potential gift planning assets. Charitable gifts of tax deferred retirement plans escape both estate and income taxation.
- If you are over age 70½, then you can direct an IRA distribution to a charity. This is called a **Qualified Charitable Distribution**. This distribution serves to satisfy all or part of your RMD requirement (RMDs begin at age 73) and prevents the distribution from being taxable. There is a \$100,000 annual limit in 2023.
- You could leave 100% or a portion of the tax deferred retirement plan to ACCF. In order to modify your IRA beneficiaries, request a "change of beneficiary" form from your financial advisor.

Bequests:

- After providing for loved ones, you could name ACCF as a beneficiary of a percentage of your assets in your estate planning documents to establish a permanent legacy of helping ACC students. Please consult with your estate planner to implement this strategy.
- In your obituary, you could inform your loved ones you would like ACCF to receive memorial gifts.

Non-Cash Donations and Real Estate:

- ACCF may benefit from donations of non-cash items that help educate students in current techniques and technologies. Examples of such donations include specialized program-related equipment in working order and hands-on training supplies. Such donations may be tax-deductible.
- Outright gifts of real estate allow the donor to avoid capital gains tax and realize a charitable deduction on the full fair market value of the real estate.
